H 1289. 1999 FEE BILL. Intro. 4/15/99. House committee substitute makes the following changes to 1st edition. Replaces original bill with AN ACT TO SET THE PUBLIC UTILITY REGULATORY FEES, TO SET THE INSURANCE REGULATORY CHARGE, TO IMPOSE THE INSURANCE REGULATORY CHARGE ON SERVICE CORPORATIONS AND ON HEALTH MAINTENANCE ORGANIZATION IN THE YEAR 2000, AND TO ALLOW THE DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES TO IMPOSE FEES THAT REFLECT THE ACTUAL COST OF RENDERING THE SERVICE. Deletes all provisions of the earlier version. Sets at nine-hundredths percent ( $0.09 \%$ ) the rate of each public utility's North Carolina jurisdictional revenues, earned each quarter, that will be used in calculating the public utility regulatory fee. Sets at $\$ 200,000$ the annual fee on the North Carolina Electric Membership Corporation. Sets at seven percent (7\%) the rate that will be used to calculate the insurance regulatory charge. Makes other changes as title indicates. Effective January 1, 2000, and applies to insurance regulatory charges levied for year 2000.
