Amends title to read AN ACT TO REQUIRE SUPERVISION OF FIRST-YEAR BAIL BONDSMEN AND RUNNERS; TO MAKE IT A CLASS I FELONY TO KNOWINGLY AND WILLFULLY FAIL TO RETURN ANY COLLATERAL SECURITY VALUED AT MORE THAN ONE THOUSAND FIVE HUNDRED DOLLARS; TO REQUIRE THAT COLLATERAL SECURITY IN THE FORM OF CASH OR NEGOTIABLE INSTRUMENTS BE HELD IN TRUST ACCOUNTS; TO PROVIDE FOR THE DISPOSITION OF OUTSTANDING BAIL BOND OBLIGATIONS UPON THE DEATH, INCAPACITATION, OR INCOMPETENCE OF A BAIL BONDSMAN; AND TO INCREASE THE MINIMUM SECURITIES REQUIRED OF PROFESSIONAL BONDSMEN. Deletes proposed new GS 58-71-40(a) that would make it a Class I felony for any person to act in capacity of bail bondsman or runner to perform any of functions, duties, or powers prescribed for bail bondsmen or runners without obtaining or maintaining a license. Makes miscellaneous changes to proposed new GS 58-71-41 concerning first-year licensees.
