H 723. DARK WINDOW INSPECTION FEE. Intro. 3/30/99. House committee substitute makes the following changes to 3rd edition. Rewrites bill as follows: (1) Amends GS 20-127(b) to provide that windshield of motor vehicle may have untinted clear film that does not obstruct vision and does reduce ultraviolet radiation from entering vehicle. (2) Amends GS 20-127(c) and adds new subsection (f) to provide for exception to windshield tinting ban for medical reasons. Exception must be based on medical evaluation that applicant has condition that causes person to be photosensitive to light, and may be valid on no more than two vehicles, for maximum of five years. Renewals thereafter must be based on new medical evaluation. Fee for permit is \$5, and permit must specify the extent to which tinting allowed. (3) Directs Division of Motor Vehicles to develop forms and computer programs to implement new exception, and to report to Joint Legislative Transportation Oversight Committee on operations under new statute. (4) Amends GS 20 183.7 to delete separate fees for safety inspections for vehicles with after factory tinted windows and for emissions and safety inspections for such vehicles; effect is to have single fee for safety inspections and emissions inspections under that section; adds separate \$10 inspection fee for after factory tinted windows, and prohibits safety inspection mechanic from inspecting tint installed pursuant to new medical exemption added by bill. Effective October 1, 1999.
