Requests Chief Justice to choose up to two of these divisions, or portions of divisions, to establish pilot programs. Areas chosen may not split district court districts. Pilots to have a designated judge to serve as coordinating judge, and a trial court administrator appointed for that purpose. Pilot to have advisory judicial council. Pilot coordinating judge, with consent of chief district and senior resident superior court judges in pilot area, to establish court schedules, assign judges, develop and implement criminal and civil calendaring system, determine when cases may be heard in other counties within judicial district; establish local rules and transfer funds within budget rules. Directs Chief Justice and Administrative Office of the Courts to report of pilot effectiveness to legislature by March 1, 2001. Appropriates \$200,00 for 1999-2000 from General Fund to Judicial Dep't for personnel and equipment to implement act Effective July 1, 1999.

S 1025. REORG. SUP. CT. DIVISIONS/PILOT FUNDS. Intro. 4/15/99. Senate committee substitute makes the following changes to 1st edition. Moves superior court district 3A from new second division to new first division for purposes of rotation of judges. Specifies that coordinating judge for pilot circuit created by act may be assisted by staff assigned by chief justice (originally by trial court administrator), and requires coordinating judge to consult with clerks of court and district attorneys in areas covered by circuit.

S 1025. REORG. SUP. CT. DIVISIONS/PILOT FUNDS. Intro. 4/15/99. Senate amendment makes the following changes to 2nd edition.
