S 1385. PRO TEM APPOINTMENTS. TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE.

Appoints Julia Bryan Jones Daniels of Wake County and Linda Godwin Murphy of Duplin County to Board of Trustees of North Carolina Museum of Art for terms expiring June 30, 2001. Terms begin July 1, 2000.

S 1385. PRO TEM APPOINTMENTS. Intro. 5/23/00. Senate committee substitute, as amended by Senate amendments #1 and #2, makes the following changes to 1st edition. (1) Names individuals as appointees to 33 state agencies and commissions. (2) Expands the membership of the Study Commission on the Future of Electric Service in North Carolina from 23 to 24 by adding the Chief Executive Officer of North Carolina Power Company or designee. (3) Expands the membership of the North Carolina Tax Policy Commission from 15 to 17 by adding one member of the General Assembly appointed by the Speaker and one appointed by the President Pro Tempore. (4) Expands the membership of the Private Protective Services Board from 10 to 14 members by adding two members of the General Assembly appointed by the Speaker and two appointed by the President Pro Tempore. (5) Adjusts the reporting dates for recommendations for membership on the Roanoke Island Commission. (6) Amends GS 160A-480.3(b), which sets the composition of governing boards of authorities created by the General Assembly which are political subdivisions of the state. Such authorities are to have boards composed of eight members, unless the authority's territorial jurisdiction is a county where the main campus of a constituent institution of UNC is located. In that case, current law says that the authority board is to have nine additional members: four appointed by the board of county commissioners, four appointed by the city council of the most populous city in the county, and one appointed jointly by the mayors of all cities in the county. This bill adds two more, by increasing the mayors' joint appointment to two and adding the chancellor of the UNC institution or his designee.

S 1385. PRO TEM/SPEAKER APPOINTMENTS. Intro. 5/23/00. House committee substitute makes the following changes to 3rd edition. Changes title to *AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE OR THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND TO MAKE CHANGES IN THE LAW RELATING TO APPOINTMENTS TO PUBLIC OFFICE.* Adds the Speaker's recommendations for appointments to various state boards and commissions including the North Carolina Real Estate Comm'n. Increases the membership of the Study Comm'n on the Future of Electric Service in North Carolina to 30 voting members including nine members of the Senate and nine members of the House of Representatives. Reduces the number of chiropractors that must serve on the State Board of Chiropractic Examiners from seven to six and provides that four of these six members are to be appointed by the Governor, and two by the General Assembly. Makes other technical changes.
