Statutory Changes.

- Roanoke Island Historical Association. Amends GS 143-200 to provide that board of directors serve three-year terms (now, two-year terms).
- First Flight Centennial Comm'n. Amends GS 143-640 to increase size of the Comm'n to 28. President Pro Tem. and Speaker each get one additional appointment.
- State-owned railroads. Amends GS 124-6 to enlarge board of directors from nine to 13 members. Gives governor two additional appointments. President Pro Tem. and Speaker each get one additional appointment.
- NC Real Estate Comm'n. Amends GS 93A-3 to enlarge Comm'n from 7 to 9 members. President Pro Tem. and Speaker each get one appointment to this agency (now, Governor appoints all members).
- Joint Legislative Comm'n on Governmental Operations. Amends GS 120-74 to enlarge membership from 30 to 34 members. President Pro Tem. and Speaker each get two additional appointments.
- Legislative Services Comm'n. Amends GS 120-31 to add two more members. President Pro Tem. and Speaker each get one more appointment.
- Joint Legislative Education Oversight Committee. Amends GS 120-70l80 to add two more members. President Pro Tem. and Speaker each get one more appointment.
- State Board of Chiropractic Examiners. Amends GS 90-139 to add one more member to be appointed by the Governor.
