H 110. VARIOUS MILITARY VETERAN LICENSE PLATES. Intro. 2/14/01. House committee substitute makes the following changes to 1st edition. Rewrites title to read *AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE SPECIAL REGISTRATION PLATES TO VETERANS OF WORLD WAR II, THE KOREAN WAR, AND THE UNITED STATES NAVY SUBMARINE SERVICE*, and amends GS 20-79.4 as title indicates.

H 110. VARIOUS NEW SPECIAL LICENSE PLATES. Intro. 2/14/01. Senate committee substitute makes the following changes to 2nd edition. Changes title to *AN ACT TO ESTABLISH A TRAFFIC CITATION PROCEDURE INVOLVING INDIVIDUALS CLAIMING DIPLOMATIC IMMUNITY AND TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE THE FOLLOWING NEW SPECIAL REGISTRATION PLATES: AUDUBON NORTH CAROLINA; FIRST IN FORESTRY; MILITARY VETERAN; WORLD WAR II VETERAN, KOREAN CONFLICT VETERAN, AND OTHER MILITARY WARTIME VETERANS FOR WHICH THE U.S. DEPARTMENT OF DEFENSE HAS AUTHORIZED A CAMPAIGN BADGE OR MEDAL; SPECIAL FORCES ASSOCIATION; U.S. NAVY SPECIALTY; THE V FOUNDATION FOR CANCER RESEARCH; HARLEY OWNERS' GROUP; ROCKY MOUNTAIN ELK FOUNDATION; AND BLUE RIDGE PARKWAY FOUNDATION.* Authorizes new registration plates as title indicates.

Provisions relating to plates for the Harley Owners' Group and the Rocky Mountain Elk Foundation expire on June 30, 2006. Also amends GS 20-183A, effective Jan. 1, 2002, to specify procedure to be used by law-enforcement officers when citing or arresting a person claiming diplomatic immunity. Procedures include verifying the driver's status and immunity, and forwarding information about the incident to the United States Dep't of State.

H 110. VARIOUS NEW SPECIAL LICENSE PLATES. Intro. 2/14/01. Conference report recommends the following changes to 4th edition to reconcile matters in controversy. Agrees to provisions of Fourth Edition Engrossed 9/19/01 with following amendments. Changes title by replacing reference to special registration plates for "Blue Ridge Parkway Foundation" with reference to "Save the Sea Turtles." Amends GS 20-79.4(b) to add special registration plate for "Save the Sea Turtles" and sets additional fee at \$20; sets out distribution of fees and minimum number of applications (300) for plate to be developed. Sets additional fee for "V Foundation for Cancer Research Division" plate at \$25. Deletes provision for state attraction plate for Blue Ridge Parkway Foundation. Deletes proposed new GS 20-183A (duties of law enforcement officers when citing or arresting person claiming diplomatic immunity). Amends GS 20-37.20, effective at earliest practical date, but no later than Jan. 1, 2003, to require Division of Motor Vehicles to notify US Dep't of State within 15 days after it receives one or more of following reports for holder of driver's license issued by US Dep't of State: (1) report of conviction for violating state law or local

ordinance concerning motor vehicle traffic control other than parking violation; or (2) report of civil revocation order.

Summarized in *Daily Bulletin* 2/14/01, 5/17/01, 9/17/01, 9/18/01, 9/19/01, and 11/27/01. Enacted Dec. 19, 2001. Section 7 is effective at the earliest practical date, but no later than Jan. 1, 2003. The remainder of this act is effective Dec. 19, 2001. Sections 1(b), 3(b), 4(b), and 6(b) expire on June 30, 2006.
