H 1144. AMEND ST. BD. OF EDUC. ADVISORY MEMBERS. Intro. 4/12/01. House committee substitute makes the following changes to 1st edition. Changes title to read *AN ACT TO APPOINT SCHOOL ADMINISTRATORS TO SERVE AS ADVISORS TO THE STATE BOARD OF EDUCATION AND TO REDUCE THE NUMBER OF STUDENT AND STATE TEACHER OF THE YEAR ADVISORS TO THE STATE BOARD OF EDUCATION* and changes short title. Adds amendment to GS 115C-11(a1) to reduce number of student advisory members of State Board of Education from two to one and to reduce term as advisory member of State Teacher of the Year from two years to one. Changes effective date from July 1, 2001, to when bill becomes law.

H 1144. REVISE BOG ELECTION PROCEDURE. Intro. 4/12/01. Senate committee substitute makes the following changes to 2nd edition. Deletes all provisions of previous bill and replaces them with *AN ACT TO REVISE THE PROCEDURE BY WHICH THE GENERAL ASSEMBLY ELECTS THE MEMBERS OF THE BOARD OF GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA AND TO STUDY THE STRUCTURE OF THE BOARD OF GOVERNORS*. Deletes provisions of GS 116-6 that reserve certain seats on the UNC Board of Governors for women, members of a minority race, and members of the political party holding a minority of seats in the General Assembly. Deletes language in GS 116-7 requiring the General Assembly to appoint the "best qualified" citizens to the Board and replaces it with a requirement that the appointed citizens be qualified by training and experience to administer the affairs of the University. Requires General Assembly to select members based upon their ability to further the University's educational mission and their economic, geographic, political, racial, sexual, and ethnic diversity. Creates the Board of Governors Study Comm'n, directs it to study the structure and mission of the Board of Governors, and requires it to report its findings and recommendations to 2002 General Assembly. Makes additional technical and conforming changes.

H 1144. REVISE BOG ELECTION PROCEDURE. Intro. 4/12/01. Conference report recommends the following changes to 3rd edition to reconcile matters in controversy. Adopts the Senate committee substitute except deletes provision creating a UNC Board of Governors Study Comm'n and makes clarifying correction.
