H 1246. BD. OF GOVS. STUDY COLLEGE ADMISSIONS MEASURES. *TO DIRECT THE BOARD OF GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA, IN COOPERATION WITH THE STATE BOARD OF EDUCATION AND THE STATE BOARD OF COMMUNITY COLLEGES, TO STUDY THE MEASURES USED FOR ADMISSIONS, PLACEMENT, AND ADVANCED PLACEMENT DECISIONS BY THE CONSTITUENT INSTITUTIONS OF THE STATE'S UNIVERSITY SYSTEM.* As title indicates. Also directs Board of Governors to develop a plan to improve measures used to assess academic performance, to adopt alternative measures, or to use some combination of both. Sets out some required subjects for the study and plan. Requires interim report to the Joint Legislative Education Oversight Committee by March 1, 2002, and final report to the Joint Legislative Commission on Education by Dec. 1, 2003. Effective July 1, 2001.

H 1246. BOG STUDY ADMISSIONS/YOUTHS IN IHES. Intro. 4/12/01. Senate committee substitute makes the following changes to 2nd edition. Changes title to *AN ACT TO DIRECT THE BOARD OF GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA, IN COOPERATION WITH THE STATE BOARD OF EDUCATION AND THE STATE BOARD OF COMMUNITY COLLEGES, TO STUDY THE MEASURES USED FOR ADMISSIONS, PLACEMENT, AND ADVANCED PLACEMENT DECISIONS BY THE CONSTITUENT INSTITUTIONS OF THE STATE'S UNIVERSITY SYSTEM, TO ALLOW INTELLECTUALLY GIFTED YOUTHS TO ATTEND COMMUNITY COLLEGES, AND TO ALLOW CERTAIN YOUTHS TO BE EMPLOYED BY INSTITUTIONS OF HIGHER EDUCATION.* As title indicates. Act modifies directions for study and adds last two provisions. Changes most study requirements from mandatory to permissive. Interim report is now permitted rather than required; deadline for final report remains the same (Dec. 1, 2003). Recommends that the study continue beyond the final report date.

Adds new GS 115D-1.1 authorizing a student under age 16 to enroll in a community college if college president or designee finds, based on State Board of Community Colleges criteria, that student is intellectually gifted and has the maturity to justify admission. Requires State Board to adopt rules to implement section. Adds new GS 95-25.5(m) to specify that youths who are enrolled at any constituent institution of UNC, any NC community college, or any college or university that awards postsecondary degrees may be employed in non-hazardous jobs with that institution. Makes act effective when it becomes law.

H 1246. BOG STUDY ADMISSIONS/YOUTHS IN IHES. Intro. 4/12/01. Conference report recommends the following changes to 3rd edition to reconcile matters in controversy. Amend new section GS 115D-1.1 to allow a student under 16 to enroll in a community college if the president of the college finds that the student is academically gifted and that the student has the maturity to attend college, and one of the following approves of the student's enrollment: (1) the local board of education if the student is enrolled in public school; (2) the administrator of the nonpublic school in which the student is enrolled; (3) the person who provides instruction for a child who is home schooled; or (4) the board of directors of the charter school in which the child is enrolled. Also provides that this section of the act will expire Sept. 1, 2004.

Summarized in *Daily Bulletin* 4/12/01, 4/23/01, 6/6/01, and 7/11/01. Enacted July 28, 2001. Effective July 28, 2001. Section 2 applies to the 2001-2002 academic year and expires Sept. 1, 2004.
