**H 1268. CAMA/MODIFY ESTUARINE BUFFER EXEMPTION/GRANTS.** Intro. 4/12/01. Senate committee substitute makes the following changes to 1st edition. Completely rewrites bill and changes title to *AN ACT TO MODIFY CERTAIN EXEMPTIONS TO THE THIRTY-FOOT BUFFER REQUIREMENT ALONG PUBLIC TRUST AND ESTUARINE WATERS AND TO PROVIDE THAT FUNDS NECESSARY TO PAY PLANNING GRANTS MADE UNDER THE COASTAL AREA MANAGEMENT ACT OF 1974 MAY BE CARRIED FORWARD TO THE NEXT FISCAL YEAR.* Section 1 sets out criteria for exemption from thirty-foot buffer requirement along public trust and estuarine waters, and provides that Coastal Resources Comm'n may grant variance from criteria under GS 113A-120.1. Sets out Comm'n's authority to adopt temporary rule to incorporate criteria; if Comm'n adopts temporary rule, Section 1 of act expires when rule becomes effective. Authorizes Environmental Review Comm'n to study standards for grant of variances under GS 113A-120.1, and comm'n may report findings and recommendations, if any, to 2002 legislative session. Amends GS 113A-112 to provide that Sec'y of Environment and Natural Resources may condition payment of grant on completion of local plan or management program and may pay grant in installments based on satisfactory completion of specific elements of plan or program and on approval by Coastal Resources Comm'n. Of funds appropriated to dep't to make grants, dep't may carry forward to next fiscal year funds in amount necessary to pay grants awarded or extended in any fiscal year.
