H 1299. UNDERGROUND STORAGE TAX PROGRAM FUNDS. Intro. 4/12/01. House committee substitute makes the following changes to 1st edition. Changes title to *AN ACT TO APPROPRIATE FUNDS FROM THE NONCOMMERCIAL LEAKING PETROLEUM UNDERGROUND STORAGE TANK CLEANUP FUND TO SUPPORT ADMINISTRATION OF THE PETROLEUM UNDERGROUND STORAGE TANK PROGRAM.* Deletes appropriation to the Commercial Leaking Petroleum Underground Storage Tank Cleanup Fund, and increases appropriation to the Noncommercial Leaking Petroleum Underground Storage Tank Cleanup Fund from \$247,500 in fiscal 2001-2002 to \$495,000 in fiscal 2001-2002 and \$495,000 in fiscal 2002-2003. Adds provision requiring the Environmental Review Comm'n to evaluate the increased funding to the Noncommercial Tank Fund, and to determine whether adjustments should be made to the Commercial Tank Fund. Comm'n to report to the 2003 General Assembly.
