H 1312. EXTEND SWINE MORATORIA/ANIMAL WASTE AMENDS-5. *TO EXTEND THE MORATORIA ON CONSTRUCTION OR EXPANSION OF SWINE FARMS, TO IMPROVE ANIMAL WASTE MANAGEMENT SYSTEM PERMITTING TO AUTHORIZE THE LEGISLATIVE RESEARCH COMMISSION TO STUDY FUNDING OPTIONS TO IMPROVE ANIMAL WASTE MANAGEMENT SYSTEMS, AND TO DIRECT THE DEPARTMENT OF COMMERCE TO DEVELOP A PLAN TO IDENTIFY AND DEVELOP MARKETS FOR BY-PRODUCTS OF ANIMAL WASTE MANAGEMENT SYSTEMS.* Extends until Sept. 1, 2003, the moratoria on construction of swine farms, waste lagoons and animal waste management systems first established by SL 1997-458. Amends GS 143-215.10C to delete provision that Environmental Management Commission's failure to act within 90 days on permit application under that section results in approval of application. Directs Legislative Research Commission to study ways to fund improvements in animal waste management systems. Directs Dep't of Commerce, in conjunction with other agencies, to identify and develop markets for by-products of animal waste.

H 1312. EXTEND SWINE MORATORIA/ANIMAL WASTE AMENDS-5. Intro. 4/12/01. House committee substitute makes the following changes to 1st edition. Changes new sunset for moratoria on construction or expansion of swine farms from Sept. 1, 2003 to July 1, 2003. Deletes provisions in bill amending GS 143-215.10C and deletes from title the words *TO IMPROVE ANIMAL WASTE MANAGEMENT SYSTEM PERMITTING*. Deletes from charge to Legislative Research Commission study of how to fund remediation of groundwater contamination.

H 1312. EXTEND SWINE MORATORIA/ANIMAL WASTE AMENDS. Intro. 4/12/01. Senate committee substitute makes the following changes to 2nd edition. Changes title to *AN ACT TO EXTEND THE MORATORIA ON CONSTRUCTION OR EXPANSION OF SWINE FARMS, TO PROVIDE FOR THE ISSUANCE OF GENERAL PERMITS FOR ANIMAL WASTE MANAGEMENT SYSTEMS UNDER ARTICLE 21 OF CHAPTER 143 OF THE GENERAL STATUTES AND THE NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES), TO EXTEND THE PILOT PROGRAM FOR INSPECTION OF ANIMAL WASTE MANAGEMENT SYSTEMS, TO AUTHORIZE THE LEGISLATIVE RESEARCH COMMISSION TO STUDY FUNDING OPTIONS TO IMPROVE ANIMAL WASTE MANAGEMENT SYSTEMS, AND TO DIRECT THE DEPARTMENT OF COMMERCE TO DEVELOP A PLAN TO IDENTIFY AND DEVELOP MARKETS FOR BY-PRODUCTS OF ANIMAL WASTE MANAGEMENT SYSTEMS.* Amends SL 1997-458, sec. 1.2, as amended by SL 1998-188, sec. 3 and SL 1999-329, sec. 2.2, to extend moratorium on permits for animal waste management systems to Sept. 1, 2003, (was, July 1, 2003). Makes technical change to GS 143-215.10(c). Deletes provision from GS 143-215.10C(c) that failure of Comm'n to act on permit application within 90 days means application is approved. Amends SL 1997-443, sec. 15.4(a), as amended by SL 1999-329, sec. 3.1, to extend pilot program of Dep't of Environment and Natural Resources from July 1, 2001, to Sept. 1, 2002. Amends SL 1999-329, sec. 3.3, to require Dep't to submit interim reports on Oct. 15, 2001, and April 15, 2002 and final report on Oct. 15, 2002. Effective June 30, 2001.

H 1312. EXTEND SWINE MORATORIA/ANIMAL WASTE AMENDS. Intro. 4/12/01. Conference report recommends the following changes to 3rd edition to reconcile matters in controversy. Changes title to *AN ACT TO EXTEND THE MORATORIA ON CONSTRUCTION OR EXPANSION OF SWINE FARMS, TO PROVIDE FOR THE ISSUANCE OF GENERAL PERMITS FOR ANIMAL WASTE MANAGEMENT SYSTEMS UNDER ARTICLE 21 OF CHAPTER 143 OF THE GENERAL STATUTES AND THE NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES), AND TO EXTEND THE PILOT PROGRAM FOR INSPECTION OF ANIMAL*

WASTE MANAGEMENT SYSTEMS. Deletes Legislative Research Comm's study of ways to fund improvements in animal waste management systems and requirement that Dep't of Commerce develop plan to identify and market by-products.
