CAMA RULE DISAPPROVED. *TO DISAPPROVE THE COASTAL AREA MANAGEMENT ACT (CAMA) RULE REGARDING OCEANFRONT SETBACK EXCEPTIONS THAT IS TO BECOME EFFECTIVE AUGUST 1, 2002.* Follows procedure for legislative disapproval of administrative rules to disapprove 15A NCAC 07H .0309, USE STANDARD FOR OCEAN HAZARD AREAS: EXCEPTIONS, so that it does not become effective. Cited rule was adopted by the Div'n of Coastal Management, Dep't of Environment and Natural Resources, and approved by the Rules Review Comm'n on Nov. 15, 2001.

H 1540. DISAPPROVE CAMA RULE. Intro. 6/6/02. House committee substitute makes the following changes to 1st edition. Changes title to read *AN ACT TO DISAPPROVE AN AMENDMENT TO THE ADMINISTRATIVE RULE "USE STANDARDS FOR OCEAN HAZARD AREAS" ADOPTED BY THE COASTAL RESOURCES COMMISSION.* Original bill disapproved the administrative rule found at 15A NCAC 07H .0309 ("Use Standards for Ocean Hazard Areas: Exceptions") in its entirety. This committee substitute disapproves the provision of the rule by which swimming pools would be deleted from the rule and approves the remainder.

Amends GS 153A-140 and GS 160A-193 to authorize counties and cities to order the removal of a swimming pool upon a finding that the swimming pool is dangerous or prejudicial to public health or safety.
