**H 1546. LEVEL 2 GDL RESTRICTION - C.F.T.F. TO PROVIDE CERTAIN OCCUPANCY LIMITATIONS FOR VEHICLES DRIVEN BY LEVEL 2 DRIVERS WITH LIMITED PROVISIONAL LICENSES.** Amends GS 20-11(e) to provide that holders of a limited provisional license may not drive a vehicle with more than one passenger under the age of 21 when not accompanied by the supervising driver. The limit does not apply to passengers who are members of the license holder's immediate family and who live in the same residence as the license holder. However, if there is a family member passenger under 21 in the car, no other passengers who are not immediate family members may be in the car.

**H 1546. LEVEL 2 GDL RESTRICTION - C.F.T.F.** Intro. 6/6/02. House committee substitute makes the following changes to 1st edition. Loosens level 2 restrictions on additional passengers in cars driven by limited provisional licensees to allow non-family-members 21 years of age and older. Changes effective date to limited provisional licenses issued on or after Oct. 1, 2002.

**H 1546. LEVEL 2 GDL RESTRICTION - C.F.T.F.** Intro. 6/6/02. House amendment makes the following changes to 2nd edition. Provides that passenger limitation does not apply to passengers who are members of the license holder's immediate family or (previously "and") whose primary residence is the same household as the license holder. Changes effective date from Oct. 1, 2002, to Dec. 1, 2002.

**H 1546. LEVEL 2 GDL RESTRICTION--C.F.T.F.** Intro. 6/6/02. Senate amendment makes the following changes to 3rd edition. Amends proposed new GS 20-11(e)(4) to provide that if family member or member of same household as license holder who is younger than 21 is passenger in vehicle, no other passengers under 21, who are not members of the license holder's immediate family or members of the license holder's household, may be in the vehicle.

**H 1546. LEVEL 2 GDL RESTRICTION - C.F.T.F.** Intro. 6/6/02. Senate amendment makes the following changes to 3rd edition. Specifies that violation of the occupancy restrictions is not negligence per se or contributory negligence. Evidence of the violation is not admissible in any civil or criminal trial other than for a violation of the statute. Also, no driver's license points or insurance surcharge can be assessed for failure to comply with occupancy requirements. Makes other clarifying changes.
