H 1640. TOWN OF DUCK WATERCRAFT AND BEAUTIFICATION. Intro. 6/13/02. House committee substitute makes the following changes to 1st edition. Changes title to read *AN ACT TO INCLUDE THE TOWN OF DUCK AS A MUNICIPALITY AUTHORIZED TO REGULATE AND CONTROL SWIMMING, PERSONAL WATERCRAFT, SURFING, AND LITTERING IN THE ATLANTIC OCEAN AND OTHER WATERWAYS ADJACENT TO THAT PORTION OF THE TOWN WITHIN ITS BOUNDARIES OR WITHIN ITS EXTRATERRITORIAL JURISDICTION AND TO DESIGNATE THE TOWN COUNCIL OF DUCK AS THE GOVERNING BODY OF THE DUCK AREA BEAUTIFICATION DISTRICT.* As title indicates. Designates the Town Council of the Town of Duck as the governing body of the Duck Area Beautification District effective Jan. 1, 2003.

H 1640. DUCK/MANTEO/CHOWAN COUNTY LOCAL AMENDMENTS (NEW). Intro. 6/13/02. House committee substitute makes the following changes to 2nd edition. Changes title to *AN ACT TO INCLUDE THE TOWN OF DUCK AS A MUNICIPALITY AUTHORIZED TO REGULATE AND CONTROL SWIMMING, PERSONAL WATERCRAFT, SURFING, AND LITTERING IN THE ATLANTIC OCEAN AND OTHER WATERWAYS ADJACENT TO THAT PORTION OF THE TOWN WITHIN ITS BOUNDARIES OR WITHIN ITS EXTRATERRITORIAL JURISDICTION; TO DESIGNATE THE TOWN COUNCIL OF THE TOWN OF DUCK AS THE GOVERNING BODY OF THE DUCK AREA BEAUTIFICATION DISTRICT; TO PERMIT THE TOWN OF MANTEO TO DECREASE THE DISTANCE WITHIN WHICH A VEHICLE MAY PARK FROM THE INTERSECTION OF CURB LINES; AND TO AMEND THE DEFINITION OF SUBDIVISION AS IT APPLIES IN CHOWAN COUNTY.* Amends Section 3 of SL 1993-610, as amended by SL 1995-101, to shift from the Dare County board of commissioners to the town council of the Town of Duck the authority to levy ad valorem taxes for maintaining sidewalks within the Duck Area Beautification District. Amends GS 20-162(a) to permit the town of Manteo to decrease the distance within which a vehicle may park from the intersection of curb lines. Amends the definition of "subdivision" as it applies to Chowan County to mean a division of a tract of land into three (now, two) or more lots, and exempts from the definition the gift of a parent of a single lot to a child or each of his or her children where no new road is involved, provided that each lot has access to a state-maintained or approved private road and there are no more than three such conveyances.

H 1640. DUCK/MANTEO/CHOWAN COUNTY LOCAL AMENDMENTS. Intro. 6/13/02. House committee substitute adopted 9/25/02 makes the following changes to 3rd edition. Makes GS 160A-176.2(a) (regarding ordinances regulating swimming and other activities in Atlantic Ocean) applicable to town of Oak Island and inapplicable to towns of Long Beach and Yaupon Beach. Provides that redefinition of subdivision in Chowan County applies to subdivisions created on or after June 16, 1992. Adds provision altering composition of Dare County Tourism Board as follows: adds additional member from town of Duck to serve initial term of two years and deletes one of three at-large members. Makes additional technical changes.

H 1640. DUCK/MANTEO/CHOWAN/BERTIE COUNTY LOCAL AMENDMENTS (NEW). Intro. 6/13/02. Senate amendment makes the following changes to 4th edition. Adds provision

establishing a no-wake zone along the Roanoke River in Bertie County and permitting enforcement upon the placement of no-wake speed zone markers along River.

SL 2002-141 (H 1640). DUCK/MANTEO/CHOWAN/BERTIE LOCAL AMENDMENTS. AN ACT TO INCLUDE THE TOWN OF DUCK AS A MUNICIPALITY AUTHORIZED TO REGULATE AND CONTROL SWIMMING, PERSONAL WATERCRAFT, SURFING, AND LITTERING IN THE ATLANTIC OCEAN AND OTHER WATERWAYS ADJACENT TO THAT PORTION OF THE TOWN WITHIN ITS BOUNDARIES OR WITHIN ITS EXTRATERRITORIAL JURISDICTION; TO DESIGNATE THE TOWN COUNCIL OF THE TOWN OF DUCK AS THE GOVERNING BODY OF THE DUCK AREA BEAUTIFICATION DISTRICT; TO PERMIT THE TOWN OF MANTEO TO DECREASE THE DISTANCE WITHIN WHICH A VEHICLE MAY PARK FROM THE INTERSECTION OF CURB LINES; TO AMEND THE DEFINITION OF SUBDIVISION AS IT APPLIES IN CHOWAN COUNTY; TO ESTABLISH A NO-WAKE ZONE IN BERTIE COUNTY; AND TO ALTER THE COMPOSITION OF THE DARE COUNTY TOURISM BOARD. Summarized in *Daily Bulletin* 6/13/02, 7/31/02, 9/5/02, 9/26/02, and 10/2/02. Enacted October 3, 2002. Sections 2-6 are effective January 1, 2003. The remainder of this act is effective October 3, 2002.
