H 168. CORPORATE ASSET TRANSFERS. Intro. 2/20/01. Senate committee substitute makes the following changes to 1st edition. Changes title to AN ACT TO PERMIT A CORPORATION TO TRANSFER ASSETS TO A WHOLLY OWNED UNINCORPORATED ENTITY, AS RECOMMENDED BY THE GENERAL STATUTES COMMISSION, AND TO MAKE TECHNICAL CHANGES TO HOUSE BILL 1073 AND SENATE BILL 842, AS ENACTED BY THE 2001 GENERAL ASSEMBLY. Makes technical changes to laws as title indicates (referenced bills were enacted as SL 2001-390 and SL 387 and relate to limited liability companies and corporations).

H 168. CORPORATE ASSET TRANSFERS RELIEF. Intro. 2/20/01. Senate committee substitute makes the following changes to 2nd edition. Changes title of bill to AN ACT TO PERMIT A CORPORATION TO TRANSFER ASSETS TO A WHOLLY OWNED UNINCORPORATED ENTITY. AS RECOMMENDED BY THE GENERAL STATUTES COMMISSION. TO AMEND THE INDEMNIFICATION PROVISIONS OF THE PATIENT'S BILL OF RIGHTS, TO SUPPORT TROOPS PARTICIPATING IN OPERATIONS ENDURING FREEDOM AND NOBLE EAGLE, AND TO PERMIT LEAVE FOR DISASTER SERVICE VOLUNTEERS. Deletes changes to S 842 (SL 2001-387) and H 1073 (SL 2001-390). Amends S 199 (SL 2001-446) to provide that managed care entity has right to indemnity against health care providers only if the health care provider has "explicitly" agreed in a written agreement separate from the managed care organization's standard professional agreement to assume responsibility for making noncertification decisions with respect to certain insureds or enrollees. However, right to indemnity does not apply to professional medical or health care services and applies only where agreement to assume responsibility was undertaken voluntarily and the managed care organization has not adversely affected the terms and conditions of the relationship with the health care provider. Grants the following benefits to deployed military personnel serving in Operation Enduring Freedom or Operation Noble Eagle: Allows Governor to extend deadlines and waive penalties (including driver's license renewals, fees for lapsed motor vehicle liability insurance); allows payment of property taxes without penalty or interest up to 90 days after end of deployment; extends period for listing of property for taxation to 90 days after end of deployment; requires community colleges for 2001-02 academic year, upon request, to refund tuition and fees to reserve and national guard personnel called to active duty and to buy back text books to extent possible: recommends constituent institutions of UNC review tuition refund policies for 2001-02 academic year based on circumstances set out in bill; and provides that students receiving NC Legislation Tuition Grant who lose full-time student status due to military service related to national emergency not be required to repay grant for that semester. Amends GS 166A-32 regarding leave from state agency for disaster service volunteer to provide that leave applies to disaster occurring within the United States not just North Carolina and to eliminate requirement that employee be a "certified" disaster service volunteer. Section regarding managed health care indemnity effective July 1, 2002, and remainder of act effective when it becomes law.

Summarized in Daily Bulletin 2/20/01, 8/28/01, and 12/6/01. Enacted Dec. 19, 2001. Section 2 is effective July 1, 2002. The remainder of this act is effective Dec. 19, 2001, and Section 1 applies to transfers occurring on or after that date.
