H 190. LOCAL FLEX. REGARDING CHARTER SCH. TEACHERS (=S 139). *TO PERMIT LOCAL FLEXIBILITY WITH REGARD TO THE REHIRING OF TEACHERS WHO LEAVE PUBLIC SCHOOLS TO TEACH IN CHARTER SCHOOLS.* Identical to S 139, introduced 2/14/01.

H 190. LOCAL FLEX. REGARDING CHARTER SCH. TEACHERS. Intro. 2/21/01. House committee substitute makes the following changes to 1st edition. Amends rather than repeals GS 115C-238.29F(e)(3). Requires local school board to grant a leave of one year to a teacher making a request to teach in a charter school. The board is not required to extend or renew such leave requests beyond the first year, but is required to give priority hiring status for three years to such teachers upon the end of that teacher's employment at a charter school.

H 190. VITICULTURE/ENOLOGY COURSE AUTHORIZATION (NEW). Intro. 2/21/01. Senate committee substitute makes the following changes to 2nd edition. Replaces original bill with bill adding new section GS 18B-1114.4 to authorize ABC Commission to authorize community college or other college to offer viticulture/enology course as part of its curriculum offered to students. For schools having such authorization, the school may manufacture wine from grapes grown on school property, possess such wine for wine-tasting seminars and other courses (but only students over 21 may consume wine) and sell wines produced to retailers or wholesalers if it obtains permit to do so under ABC laws. Permission to conduct the viticulture/enology program expires on June 30, 2004. Amends GS 66-58(c) to exempt these programs from that law, which generally prohibits government agencies from selling goods available in private sector. Amends GS 18B-1101(2a) to allow winery to use wine produced inside NC in same manner as it can use wine produced outside NC, and subject to same limitations.

H 190. VITICULTURE/ENOLOGY COURSE AUTHORIZATION. Intro. 2/21/02. Senate amendment makes the following changes to committee substitute, adopted today: Limits school having these programs from using more than five acres as a vineyard.

AN ACT TO ALLOW THE HOLDER OF A VITICULTURE/ENOLOGY COURSE AUTHORIZATION TO MANUFACTURE, POSSESS, AND SELL WINE FOR CERTAIN LIMITED PURPOSES AS A PART OF A COMMUNITY COLLEGE'S OR COLLEGE'S VITICULTURE/ENOLOGY PROGRAM.
