**H 377. DSS CHANGES-2.** Intro. 3/1/01. House committee substitute makes the following changes to 1st edition. (1) Adds amendment to GS 50-13.9 specifying that payment records maintained by a designated child support enforcement agency are admissible evidence and may be authenticated by the designated representative in any action establishing, enforcing, or modifying a child support order. (2) Adds a new GS 110-136.11 to require that the National Medical Support Notice is to be used to notify employers and health insurers or health care plan administrators of an order entered for dependant health benefit plan coverage in a IV-D case. Adds new GS 110-136.12 concerning the obligations of the IV-D agency to serve the National Medical Support Notice on the employer of an order for dependent health benefit plan coverage with respect to one of its employees, new GS 110-136.13 concerning the obligations of the employer once the National Medical Support Notice has been served to notify the health insurer or health plan and to withhold the appropriate amount to cover the costs of the dependent coverage, and new GS 110-136.14 concerning the obligations of the health insurer or health plan upon receipt of delivery of the National Medical Support Notice from the employer. (3) Amends GS 50-13.4(f) to clarify that a child support judgment that provides for periodic payments is enforceable by civil and criminal contempt.
