**H 432. LICENSING SELLING OF CARS. TO ESTABLISH PENALTIES FOR SELLING CARS IN VIOLATION OF THE MOTOR VEHICLE DEALERS AND MANUFACTURERS LICENSING LAW, TO ESTABLISH EDUCATIONAL REQUIREMENTS REQUIRED FOR ISSUANCE AND RENEWAL OF LICENSURE FOR USED MOTOR VEHICLE DEALERS, AND TO INCREASE FEES.** Amends GS 20-287 to establish penalties for violation of licensing requirements, setting criminal penalty as a Class 2 misdemeanor and civil penalties at maximum of \$1000 per violation for licensee violations and \$5000 per violation for persons who have not obtained a license. Amends GS 20-288 to clarify persons who must obtain licenses and to set out process and criteria (including training requirements) for used motor vehicle dealer licenses. Raises license fee in GS 20-289(a) for motor vehicle sales representatives to \$15 (was, \$10). Effective June 30, 2001.

**H 432. LICENSING SELLING OF CARS.** Intro. 3/1/01. House committee substitute makes the following changes to 1st edition. Changes title to *AN ACT TO ESTABLISH CIVIL PENALTIES FOR SELLING CARS IN VIOLATION OF THE MOTOR VEHICLE DEALERS AND MANUFACTURERS LICENSING LAW, AND TO ESTABLISH EDUCATIONAL REQUIREMENTS FOR ISSUANCE AND RENEWAL OF LICENSURE FOR USED MOTOR VEHICLE DEALERS.* Makes person who violates section requiring license guilty of a class 1 misdemeanor (was, class 2). Authorizes Div'n of Motor Vehicles to levy civil penalties against licensees who violate any provision of law relating to the sale of vehicles, vehicle titling, or vehicle registration. Deletes provisions increasing dealer license fee from \$10 to \$15. Makes additional technical and conforming changes. Changes effective date to July 1, 2002 (was June 30, 2001).

**H 432. LICENSING SELLING OF CARS.** Intro. 3/1/01. House amendment makes the following changes to 2nd edition. Exempts persons age 62 or older from the requirement of completing a licensing course approved by DMV to obtain a license.

**H 432. LICENSING SELLING OF CARS.** Intro. 3/01/01. Senate committee substitute makes the following changes to 3rd edition: (1) deletes provisions making it a Class 1 misdemeanor to violate any provision relating to licensing requirements; (2) provides that the course-completion requirements do not apply to a manufactured home dealer licensed under GS 143-143.11 who complies with the continuing education requirements of GS 143-143.11B; (3) provides that neither the course-completion requirements nor the application-fee requirement apply to persons age 62 or older, as of July 1, 2002, who are seeking a renewal license; and (4) clarifies that the act applies to licenses issued to used motor vehicle dealers on or after the effective date of July 1, 2002.

**H 432. LICENSING SELLING OF CARS.** Intro. 3/1/01. Senate amendment makes the following changes to 4th edition. Amends proposed GS 20-287(b) and 20-287(c) to substitute violation of GS 20-285 through GS 20-303 for reference to violation of Article 12, GS Ch. 20.

Effective July 1, 2002, and applies to violations and offenses committed on or after that date and licenses issued to used motor vehicle dealers on or after that date.
