H 439. CIVIL PROCEDURE RULE CHANGES. TO AMEND THE RULES OF CIVIL

PROCEDURE AS RECOMMENDED BY THE CIVIL LITIGATION STUDY COMMISSION.

Amends Rule 4(a) to allow a notary public commissioned in NC to serve a summons and complaint. Amends Rule 4(c) by extending the time for service of a summons from 30 days to 60 days. Amends Rule 4(j) by authorizing an additional method of service by a "designated delivery service" authorized pursuant to 28 U.S.C. sec. 7502(f)(2). Amends Rule 5(b) by authorizing an additional method of service of pleadings and papers to include service by fax. Amends Rule 28(c) to allow a videotaped deposition to be taken by a disqualified person if certain conditions are met. Amends Rule 37(a)(2) by requiring that the moving party certify that it has in good faith conferred or attempted to confer with the person failing to make discovery in an effort to secure the information or material without court action. Amends Rule 46(b) by (1) clarifying that it applies to pretrial rulings, interlocutory orders, trial rulings and other orders not directed to the admissibility of evidence, (2) clarifying a party's need to make an exception on the record upon having an opportunity to do so, and (3) repeals subsection (c). Amends Rule 63 by broadening the situations in which a judge may be substituted. Amends Rule 65(b) to enhance the opportunity for notice to the adverse party. Makes conforming changes. Effective Oct. 1, 2001, and applies to actions filed on or after that date.
