H 612. NEUSE RIVER WATER QUALITY RECLASSIFICATION. Intro. 3/14/01. House committee substitute makes the following changes to 1st edition: (1) changes title to *AN ACT TO SPECIFY THE EFFECTIVE DATE OF THE ADMINISTRATIVE RULE RECLASSIFICATION BY THE ENVIRONMENTAL MANAGEMENT COMMISSION OF CERTAIN WATERS IN THE NEUSE RIVER BASIN BELOW FALLS LAKE DAM THAT WOULD HAVE THE EFFECT OF ALLOWING THE TOWN OF WAKE FOREST TO WITHDRAW ADDITIONAL WATER FROM THE NEUSE RIVER AND TO PROVIDE THAT THE 2004 REGULAR SESSION OF THE 2003 GENERAL ASSEMBLY MAY DISAPPROVE THE RULE* and (2) provides that notwithstanding GS 150B-21.3 (governing the procedure for fixing the effective date of permanent administrative rules), the rule described in title (15A NCAC 2B.0315), as amended by the Environmental Management Comm'n on Oct. 12, 2000, and approved by the Rules Review Comm'n on Nov. 16, 2000, becomes effective on July 1, 2004, unless the 2004 General Assembly specifically disapproves it by enacting an appropriate bill.
