Additional member will be appointed by Lt. Governor and must have been a registered veterinary technician in NC for at least five years preceding his or her appointment.

H 722. EXPAND VET. BD./INJUNCTION FOR CHIROPRACTIC BD. Intro. 3/22/01. Senate committee substitute makes the following changes to 1st edition: (1) changes title to *AN ACT TO INCREASE THE MEMBERS OF THE NORTH CAROLINA VETERINARY MEDICAL BOARD FROM SEVEN TO EIGHT AND TO ALLOW THE BOARD OF CHIROPRACTIC EXAMINERS TO BRING AN ACTION FOR INJUNCTIVE RELIEF IN SUPERIOR COURT TO PREVENT PERSONS FROM PRACTICING CHIROPRACTIC WITHOUT A LICENSE*; and (2) amends GS 90-147 to allow the Board of Chiropractic Examiners to bring an action for injunction to prevent practice without a license regardless of whether criminal prosecution has been or may be instituted.

H 722. EXPAND VET. BD./INJUNCTIONS FOR CHIROPRACTIC BD. Intro. 3/22/01. Conference report recommends the following changes to 2nd edition to reconcile matters in controversy. Amends GS 90-182(a) to provide that General Assembly shall appoint one member each upon recommendation of President Pro Tem. of the Senate and upon recommendation of Speaker of House of Representatives, and amends GS 20-182(c) to provide that no member appointed to Board by Lieutenant Governor, Speaker of the House of Representatives, or General Assembly shall serve more than two complete consecutive five-year terms.
