H 765. MODIFY VANCE OCCUPANCY TAX. TO AUTHORIZE VANCE COUNTY TO LEVY AN ADDITIONAL THREE PERCENT ROOM OCCUPANCY TAX AND TO MAKE OTHER CHANGES TO THE VANCE COUNTY ROOM OCCUPANCY TAX. Amends SL 1987-1067, which authorized Vance County to levy a 3% room occupancy tax and required that 50% of taxes so levied be used for purposes related to tourism. Authorizes Vance County to levy an additional 3% room occupancy tax. Provides that such taxes are subject to the penalties provided in GS 153A-155, and that the taxes must be levied, administered, collected, and repealed as provided in that section. Makes additional technical and conforming changes.

H 765. MODIFY VANCE OCCUPANCY TAX. Intro. 3/26/01. House committee substitute makes the following changes to 1st edition. Adds provision to SL 1987, Chap. 1067, Sec. 1(e), that Vance Tourism Development Authority shall use at least two-thirds of the funds remitted to promote travel and tourism in Vance County, with remainder for tourism-related expenditures. Adds Sec. 2 to create Vance Tourism Development Authority by resolution of board of comm'rs, provide for membership in Authority, and establish duties.

H 765. MODIFY VANCE OCCUPANCY TAX. Intro. 3/26/01. Senate amendment makes the following changes to 2nd edition. Provides that if H 757 (Raise Washington Occupancy Tax) becomes law, then instead of the amendment to GS 153-155(g) providing "Uniform provisions for room occupancy taxes," H 757 will be amended to include Vance county.
