Amends sec. 3 of SL 1999-288 to allow Bertie, Camden, Chowan, Currituck, Pasquotank, Perquimans, Tyrrell, and Washington to adopt an ordinance providing that a fee for the inspection, maintenance, and repair of provisionally approved septic tank or other innovative system may be made payable and collected in any manner by which property taxes may be collected. Amendment to sec. 3 applies to fees imposed for inspections, maintenance, or repair performed on or after effective date Intro. by Owens.
