**S 1109. 2001 ADJOURNMENT RESOLUTION. SETTING THE TIME FOR ADJOURNMENT OF THE 2001 GENERAL ASSEMBLY TO MEET IN 2002 AND LIMITING THE SUBJECTS THAT MAY BE CONSIDERED THAT IN SESSION.** Sets adjournment on December 5, 2001, and provides that the General Assembly will reconvene at 12:00 noon on Monday, May 27, 2002.

Limits subjects that may be considered in 2002 to the following. (1) Bills directly affecting the fiscal 2002-2003 state budget, which must be submitted to Bill Drafting by 4:00 p.m. on June 6, 2002, and must be introduced in the House or filed for introduction in the Senate no later than 4:00 p.m. on June 13, 2002. (2) Bills introduced in 2001 that have passed third reading in the house in which introduced and received and not disposed of in the other house. (3) Bills and resolutions implementing recommendations of study and statutory commissions, which must be submitted to Bill Drafting no later than 4:00 p.m. on May 29, 2002, and must be filed for introduction in the Senate or introduced in the House no later than 4:00 p.m. on June 5, 2002. (4) Local bills submitted to Bill Drafting by 4:00 p.m. on June 5, 2002, introduced in the House or filed for introduction in the Senate by 4:00 p.m. on June 12, 2002, and accompanied by a certificate from the principal sponsor stating that it meets rules about being noncontroversial and approved by the entire delegation. (5) Selection, appointment, or confirmation of state boards and commissions required by law. (6) Any matter authorized by a joint resolution passed during the 2002 Regular Session by a two-thirds majority vote of the House and Senate, and a joint resolution authorizing the introduction of bill pursuant to this provision. (7) Bills primarily affecting any state or local pension or retirement system, submitted to Bill Drafting no later than 4:00 p.m. on June 5, 2002, and introduced in the House or filed for introduction in the Senate by 4:00 p.m., June 12, 2002. (8) Joint resolutions, House resolutions, and Senate resolutions pertaining to Article III, Sec. 5(10) of the North Carolina Constitution, or authorized for introduction under Senate Rule 40(b) or House Rule 31(g). (9) A joint resolution adjourning the 2001 Regular Session, sine die. (10) Bills to disapprove rules under GS 150B-21.3. (11) Constitutional amendments.

Prohibits the introduction of bills containing no substantive provisions in the House of Representatives during the session. Permits the Speaker and President Pro Tem to authorize committees to meet between sessions, but prohibits committees from considering bills originating in the other house during this time. Authorizes the meeting of conference committees.
