S 1111. CERTAIN 2002 APPROPRIATIONS ACT MODIFICATIONS. Intro. 5/29/02. Senate committee substitute makes the following changes to 1st edition. Revises title to read *TO CONTINUE CURRENT DIRECTIONS AND LIMITATIONS ON THE EXPENDITURES OF STATE FUNDS, TO AUTHORIZE THE USE OF THE SAVINGS RESERVE ACCOUNT TO BALANCE THE BUDGET, TO PROVIDE THAT THERE BE NO AUTOMATIC STEP INCREASES FOR STATE AND PUBLIC SCHOOL EMPLOYEES, TO SET THE CONTRIBUTION RATE TO THE TEACHERS' AND STATE EMPLOYEES' RETIREMENT SYSTEM, TO APPROPRIATE FUNDS FOR HEALTH AND HUMAN SERVICES BLOCK GRANTS, NATURAL AND ECONOMIC RESOURCES BLOCK GRANTS, AND FOR WORKER TRAINING TRUST FUND PROGRAMS, AND TO MAINTAIN 2001-2002 PARTICIPATION LEVELS IN THE AIDS DRUG ASSISTANCE PROGRAM.* As title indicates. Bars magistrates, assistant and deputy clerks of superior courts, members of the State Highway Patrol and public school employees paid on the teacher salary schedule or school-based administrator salary schedule from receiving automatic step increases. Changes retirement contribution rates for state employees for fiscal 2002-2003 to: 3.03% for teachers and state employees (was, 5%); 8.03% for law enforcement officers (was, 10%); 13.67% for judicial retirement system (was, 16.40%); and 2.35% for legislative retirement system (was, 25.55%). Appropriates the following amounts for DHHS block grants: \$15,639,392 for community services, \$27,355,275 for social services, \$19,849,342 for low-income energy, \$9,855,277 for mental health services, \$36,455,601 for substance abuse prevention and treatment, \$165,603,500 for child care and development funds, \$206,200,813 for temporary assistance to needy families, \$16,928,823 for maternal and child health, and \$3,061,182 for preventative health services, all for the fiscal year ending June 30, 2003. Effective July 1, 2002, and expires July 31, 2002, except as provided in particular sections.
