S 113. CABARRUS WORK OVER WELFARE. TO EXTEND THE CABARRUS COUNTY WORK OVER WELFARE PROGRAM. Amends SL 1998-106, which established the Cabarrus County Workfare Program. Changes name to Cabarrus County Work Over Welfare Program. Deletes requirement that program provide child care. Adds the following requirements: (1) requires children's SSI income to be counted when a family's eligibility for program is determined; (2) makes program beneficiaries who voluntarily terminate employment without good cause ineligible for program benefits, except for employment services; (3) requires program applicants to meet with child support staff; (4) provides that a person convicted of felony fraudulent misrepresentation in obtaining public assistance will be permanently ineligible for program benefits; (5) authorizes one-time payments of up to \$1200 to divert potentially eligible persons from program; (6) exempts parents of newborn children from work requirements for three months; and (7) requires reassessment of family service needs when an able-bodied, financially responsible adult moves into the home. Extends program to July 1, 2003 (was to terminate on July 1, 2001). Makes additional technical and clarifying changes.

S 113. CABARRUS WORK OVER WELFARE. Intro. 2/12/01. Senate committee substitute makes the following changes to 1st edition. Adds additional provisions regarding social work following termination of assistance to families with children. Revises provision regarding Medicaid coverage of individuals and children following termination of Work First assistance. Deletes provision requiring consideration of child's SSI benefits in determining eligibility. Makes additional technical changes.

S 113. CABARRUS WORK OVER WELFARE. Intro. 2/12/01. House committee substitute makes the following changes to 2nd edition. Specifies that all children in Cabarrus county be evaluated for Health Choice eligibility any time Work First terminates, and that there be no sanction for individuals who fail to comply with program requirements because necessary child care is not available. Deletes provision requiring that any recipient convicted of fraudulent misrepresentation be permanently disqualified from participation in Work First.
