S 1232. FIRE AND RESCUE AMENDMENT. Intro. 6/602. House committee substitute makes the following changes to 1st edition. Changes title to *AN ACT TO ALLOW MEMBERS OF THE NORTH CAROLINA FIREMEN'S AND RESCUE SQUAD WORKERS' PENSION FUND WITH AT LEAST TEN YEARS OF SERVICE TO CONTINUE AS MEMBERS AFTER THE TAKEOVER OF A VOLUNTEER DEPARTMENT BY A CITY OR COUNTY; AND TO EXEMPT VOLUNTEER FIREFIGHTERS, EMERGENCY MEDICAL SERVICES PERSONNEL AND RESCUE SQUAD WORKERS FROM OVERTIME AND MINIMUM WAGE LAWS. Adds new GS 95-25.14(b1), effective for hours worked on or after July 31, 2002, to provide that provisions of GS 95-25.3 (minimum wage) and GS 95-25.4 (overtime), and the provisions of GS 95-25.15(b) (record keeping) as they relate to exemptions provided in subsection, do not apply to (1) hours worked as bona fide volunteer firefighter in incorporated, nonprofit volunteer or community fire dep't; and (2) hours worked as bona fide volunteer or community fire dep't or incorporated, nonprofit rescue squad.*

SL 2002-113 (S 1232). FIRE AND RESCUE AMENDMENT. AN ACT TO ALLOW MEMBERS OF THE NORTH CAROLINA FIREMEN'S AND RESCUE SQUAD WORKERS' PENSION FUND WITH AT LEAST TEN YEARS OF SERVICE TO CONTINUE AS MEMBERS AFTER THE TAKEOVER OF A VOLUNTEER DEPARTMENT BY A CITY OR COUNTY; AND TO EXEMPT VOLUNTEER FIREFIGHTERS, EMERGENCY MEDICAL SERVICES PERSONNEL AND RESCUE SQUAD WORKERS FROM OVERTIME AND MINIMUM WAGE LAWS.

Summarized in Daily Bulletin 6/6/02 and 7/17/02. Enacted September 6, 2002. This act is effective when it becomes law, with Section 1 applying to members of the Firemen's and Rescue Squad Workers' Pension Fund with at least 10 years of service on or after January 1, 2002, and Section 2 applying to hours worked on or after July 31, 2002.
