In section regarding State Elections Board's authority to order new election, deletes proviso requiring State Board to adopt findings of county elections board when State Board orders new election after public hearing held by county elections board. Makes additional technical corrections or changes.

S 16. MUNICIPAL ELECTION BDS. Intro. 1/29/01. House committee substitute makes the following changes to 2nd edition. Changes title to AN ACT TO ABOLISH MUNICIPAL BOARDS OF ELECTIONS IN MUNICIPALITIES OTHER THAN MORGANTON, GRANITE FALLS, OLD FORT, AND RHODHISS. Completely rewrites 2nd edition and adds new GS 163-280.1 as title indicates. Act becomes effective Jan. 1, 2002, and applies to all primaries and elections held on and after that date. Provides that this act prevails over local acts. Terms of all members of all municipal board of elections are abolished, and terms of all precinct officials appointed by municipal boards of elections, if those terms have not expired before Jan. 1, 2002, expire Jan. 1, 2002. Amends GS 163-285 to provide that municipalities cited in title may conduct their own elections or they may request county board of elections to conduct elections. Adds new provisions to GS 163-285 as follows: (1) county boards of elections have authority to require maps or definitive outlines of boundaries constituting any municipality or special district (sanitary district, fire district, or school administrative unit) whose elections county board administers and must be immediately advised of any change or relocation of such boundaries; and (2) any contested election or allegations of irregularities in municipal or special district election must be made to county board of elections and appeals from such rulings may be made to State Board of Elections under existing statutory provisions and rules adopted by board.
