S 202. AMEND FISHERIES LAW. Intro. 02/22/01. House committee substitute makes the following changes to 1st edition. Changes title to *AN ACT TO AMEND THE PROCESS BY WHICH FISHERIES MANAGEMENT PLANS ARE REVISED, TO REPEAL THE SUNSETS ON THE LICENSING PROVISIONS OF THE FISHERIES REFORM ACT OF 1997 AND THE MARINE FISHERIES AMENDMENTS OF 1998, TO EXTEND THE MORATORIUM ON ISSUING NEW SHELLFISH LEASES IN CORE SOUND, AND TO STAGGER THE TERMS OF MEMBERS OF THE MARINE FISHERIES COMMISSION, AS RECOMMENDED BY THE JOINT LEGISLATIVE COMMISSION ON SEAFOOD AND AQUACULTURE.* Adds sections to bill as new title indicates. Repeal of sunset provisions and extension of moratorium effective July 1, 2001, and staggering of terms for Comm'n members effective June 30, 2001.
