S 243. MARSHVILLE/STALLINGS RED LIGHT CAMERAS. *TO AUTHORIZE THE TOWNS OF MARSHVILLE AND STALLINGS IN UNION COUNTY TO USE PHOTOGRAPHIC IMAGES AS PRIMA FACIE EVIDENCE OF A TRAFFIC VIOLATION AND TO PREVENT INSURANCE POINTS FROM BEING ASSESSED.* Amends GS 160A-300.1 as title indicates.

S 243. MARSHVILLE/STALLINGS RED LIGHT CAMERAS. Intro. 2/26/01. Senate committee substitute makes the following changes to 1st edition. Changes title to *AN ACT TO AUTHORIZE THE CITY OF CONCORD IN CABARRUS COUNTY AND THE CITY OF MONROE AND THE TOWNS OF MARSHVILLE AND STALLINGS IN UNION COUNTY TO USE PHOTOGRAPHIC IMAGES AS PRIMA FACIE EVIDENCE OF A TRAFFIC VIOLATION AND TO PREVENT INSURANCE POINTS FROM BEING ASSESSED.* Makes act applicable to the cities of Concord and Monroe.

S 243. RED LIGHT CAMERAS/CERTAIN CITIES. Intro. 2/26/01. Senate amendment makes the following changes to 3rd edition. Changes title to *AN ACT TO AUTHORIZE CERTAIN CITIES AND TOWNS TO USE PHOTOGRAPHIC IMAGES AS PRIMA FACIE EVIDENCE OF A TRAFFIC VIOLATION AND TO PREVENT INSURANCE POINTS FROM BEING ASSESSED.* Adds Cities of Cary, Durham, Hickory, Raleigh, and Newton, and Town of Mineral Springs.

S 243. RED LIGHT CAMERAS/CERTAIN CITIES. Intro. 2/26/01. House committee substitute makes the following changes to 4th edition. Deletes Hickory and Newton from the bill.

April 16, 2001

S 243. RED LIGHT CAMERAS/CERTAIN MUNICIPALITIES. Intro. 2/26/01. House committee substitute makes the following changes to 5th edition. Extends bill's coverage to all municipalities in Union county, and to Albemarle and Nags Head, and deletes Raleigh from bill's coverage.

S 243. RED LIGHT CAMERAS/CERTAIN MUNICIPALITIES. Intro. 2/26/01. House committee substitute makes the following changes to 6th edition. Changes title to *AN ACT TO AUTHORIZE CERTAIN MUNICIPALITIES TO USE TRAFFIC CONTROL PHOTOGRAPHIC SYSTEMS AND TO AUTHORIZE THE MUNICIPALITIES IN WAKE COUNTY TO USE RED LIGHT CAMERAS FOR SAFETY, FOR SCHOOLS, BUT NOT FOR PROFIT.* Retains provisions of sixth edition that added certain municipalities as title indicates, although removes Town of Cary from that list. Adds new GS 160A-300.2 to authorize all municipalities within Wake County (if 51% or more of municipality's land is in Wake County) to install traffic control photographic systems as set out in bill. Provides that municipality may enter into only one contract for lease, lease-purchase, or purchase of system and duration of contract may be for no more than 60 months. Provides that clear proceeds from citations must be paid to county school fund. Clear proceeds is defined as funds remaining after paying for system, paying contractor to operate system, and paying any administrative costs incurred by municipality related to use of system.

S 243. RED LIGHT CAMERAS/CERTAIN MUNICIPALITIES. Intro. 2/26/01. Senate amendment makes the following changes to 7th edition. Makes subsection (e) of GS 160A-300.2, regarding duration of yellow light change interval, applicable to the City of Wilmington.

S 243. RED LIGHT CAMERAS/CERTAIN MUNICIPALITIES. Intro. 2/26/01. House amendments make the following changes to 7th edition. Add new GS 160A-300.1(c1) to provide that duration of yellow light change interval at intersections where traffic control photo systems are in use shall be no less than yellow light change interval duration specified in Design Manual developed by Signals and Geometrics Section of NC Dep't of Transportation. Provide that for City of Concord and all municipalities in Union County, clear proceeds from citations issued under ordinance shall be paid to county school fund. Define clear proceeds as funds remaining after paying for lease, lease-purchase, or purchase of traffic control photo system; paying contractor for operating system; and paying any administrative costs incurred by municipality concerning use of system.

S 243. RED LIGHT CAMERAS/CERTAIN MUNICIPALITIES. Intro. 2/26/01. Conference report recommends the following changes to 8th edition to reconcile matters in controversy. Changes title to *AN ACT TO AUTHORIZE CERTAIN MUNICIPALITIES TO USE TRAFFIC CONTROL PHOTOGRAPHIC SYSTEMS AND TO AUTHORIZE CERTAIN MUNICIPALITIES TO USE RED LIGHT CAMERAS FOR SAFETY, FOR SCHOOLS, BUT NOT FOR PROFIT*. Amends GS 160A-300.1(d) to delete City of Concord from list of covered municipalities and adds GS 160A-300.3 specifying use of traffic control photographic systems in City of Concord.

RED LIGHT CAMERAS/CERTAIN MUNICIPALITIES. *AN ACT TO AUTHORIZE CERTAIN MUNICIPALITIES TO USE TRAFFIC CONTROL PHOTOGRAPHIC SYSTEMS AND TO AUTHORIZE THE MUNICIPALITIES IN WAKE COUNTY TO USE RED LIGHT CAMERAS FOR SAFETY, FOR SCHOOLS, BUT NOT FOR PROFIT*.
