S 300. AMEND NC EMERGENCY MANAGEMENT LAWS (=H 451). *TO AMEND THE LAWS REGARDING EMERGENCY MANAGEMENT AS RECOMMENDED BY THE LEGISLATIVE DISASTER RESPONSE AND RECOVERY COMMISSION.* Identical to H 451, introduced 3/1/01.

S 300. AMEND NC EMERGENCY MANAGEMENT LAWS. Intro. 3/5/01. Senate committee substitute makes the following changes to 1st edition. (1) Deletes the bill's provisions creating the possibility of the Governor's declaring a "state of emergency" in addition to the current law's provisions for declaring a "state of disaster." (2) Deletes bill's provisions adding new GS 166A-6(a11) providing for the power of the Governor to order the evacuation of public buildings if the Governor determines that "a great public crisis, disaster, riot, catastrophe, or any other similar public emergency exists" or is imminent. (3) Completely revises the bill's provisions for the distribution of disaster assistance funds by rewriting new GS 166A-6A to (i) provide that state disaster assistance funds are to be used to provide grants to individuals who are unable to meet disaster-related necessary expenses or other serious needs resulting from a disaster and to political subdivisions of the State and nonprofit utilities; and (ii) set out purposes for which funds may be provided to individuals, political subdivisions, or nonprofit utilities in Type I, Type II, and Type III disasters (as defined in the committee substitute in ways substantially similar to definitions in original bill). (4) Deletes original bill's provisions regarding powers of municipalities and county commissioners. (5) Deletes provision repealing GS 14-288.12 through 14-288.17 and GS 14-288.19.

S 300. AMEND NC EMERGENCY MANAGEMENT LAWS. Intro. 3/5/01. House committee substitute makes the following changes to 2nd edition. Deletes definition of "Contiguous Counties or Other Political Subdivisions." Revises definition of "Disaster Area" to be the area covered by a proclamation of disaster under GS 166A-6(a1). Adds new definition of "Stafford Act" with citation to federal disaster relief statutes. Amends GS 166A-6(b) to provide that a state of disaster declared before July 1, 2001 (was, January 1, 2002), terminates by proclamation of Governor or resolution of the General Assembly. Changes criteria for providing public assistance under GS 166A-6A(b)(2) for disaster proclaimed after August 1, 2002, to require the eligible entity to participate in the National Flood Insurance Program and have an approved hazard mitigation plan. Changes effective date to July 1, 2001 (was, Dec. 1, 2001). Makes other technical and clarifying changes.
