INSURANCE PRODUCER LICENSING (=H 346). *TO REVISE THE LAWS ON LICENSING OF INSURANCE AGENTS AND BROKERS TO MAKE THEM CONFORM TO A MODEL UNIFORM INSURANCE PRODUCER LICENSING ACT OF THE NATIONAL ASSOCIATION OF INSURANCE COMMISSIONERS AND THEREBY, ALONG WITH THE OTHER STATES, ACHIEVE NATIONAL UNIFORMITY IN LICENSING INSURANCE PRODUCERS, AS PROVIDED BY THE FEDERAL GRAMM-LEACH-BLILEY ACT, PUBLIC LAW 106-102.* Identical to H 346, introduced 3/1/01.

S 318. INSURANCE PRODUCER LICENSING. Intro. 3/5/01. Senate committee substitute makes the following changes to 1st edition. Modifies new GS 58-33-46 to delete provision permitting Comm'r to suspend, revoke, or refuse license to business entity when entity knew or should have known of individual licensee's violation of section and entity did not report to Comm'r or undertake corrective action. Adds revision of GS 58-21-40, concerning surplus lines advisory organization (renamed surplus lines regulatory support organization, to add responsibilities to organization regarding nonresident surplus lines licensees; makes this revision effective Oct. 1, 2001. Makes change to GS 58-33-85(b) (in original bill) effective when bill becomes law.

S 318. INSURANCE PRODUCER LICENSING. Intro. 3/5/01. House committee substitute makes the following changes to 2nd edition. Amends GS 58-33-31 to provide that individual applying for license has successfully passed any examinations required by GS 58-33-30(e) (was, has successfully passed the examinations for the kinds of insurance for which the person has applied). Makes stylistic change to GS 58-33-32. Makes technical change to GS 58-33-30(a). Amends GS 58-39-15(3) to provide that term "agent" has the meaning as set forth in GS 58-33-10, and includes limited representatives, limited line credit insurance producers, limited lines producers, insurance producers, and surplus lines licensees.
