**S 34. CONTINUE STATE BUDGET.** Intro. 2/5/01. Senate committee substitute makes the following changes to 1st edition. Replaces blank bill with *AN ACT TO EXTEND THE EXPIRATION DATE OF THE LEGISLATION AUTHORIZING THE DIRECTOR OF THE BUDGET TO CONTINUE EXPENDITURES FOR THE OPERATION OF GOVERNMENT AT THE LEVEL IN EFFECT ON JUNE 30, 2001, AND EXTENDING EXPIRING PROVISIONS OF LAW; TO APPROPRIATE FUNDS FOR THE STATE EMPLOYEE HEALTH BENEFIT PLAN; TO EXTEND ESTABLISHED PAYMENTS FOR MEDICAL TREATMENTS AND SERVICES TO WORKERS' COMPENSATION PATIENTS; AND TO CLARIFY STATUTORY SALARY INCREASES.* Amends SL 2001-250, as amended by SL 2001-287, to extend continuing authority through Aug. 29, 2001. Appropriates \$36 million from General Fund for 2001-02 to State Employee Health Benefit Plan. Amends SL 2001-253 to extend established hospital payment schedules for workers' compensation patients through Sep. 1, 2001. Amends SL 2001-250 to provide that all statutorily mandated salary increases for teachers and other state employees are held in abeyance until adoption of the budget for the 2001-03 biennium.

**S 34. CONTINUE STATE BUDGET.** Intro. 2/5/01. House committee substitute makes the following changes to 2nd edition and amends title by adding the phrase *AND TO AUTHORIZE PRISON CONSTRUCTION.* Adds section authorizing Dep't of Administration and Dep't of Correction to contract for construction of three new close-custody prisons at contract price not to exceed total bid price submitted by selected vendor on 4/17/01; sites to be in Anson, Alexander, and Scotland counties. Provides that final contract proposal is subject to review and approval by Council of State.
