S 367. LOW-INCOME HOUSING CREDIT PROGRAM EXEMPT/APA. Intro. 3/7/01. Senate committee substitute makes the following changes to 1st edition. Rewrites bill so it is now entitled *AN ACT TO EXEMPT THE NORTH CAROLINA FEDERAL TAX REFORM ALLOCATION COMMITTEE AND THE NORTH CAROLINA HOUSING FINANCE AGENCY FROM THE RULE-MAKING REQUIREMENTS OF THE ADMINISTRATIVE PROCEDURE ACT WITH REGARD TO ADOPTION OF THE QUALIFIED ALLOCATION PLAN, AND TO AUTHORIZE THE JOINT LEGISLATIVE ADMINISTRATIVE PROCEDURE OVERSIGHT COMMITTEE TO STUDY THE APPLICABILITY OF THE ADMINISTRATIVE PROCEDURE ACT TO THESE AGENCIES.* Adds new GS 150B-1(d) for rule-making exemption mentioned in title and authorizes study mentioned in title.

S 367. LOW-INCOME HOUSING CREDIT PROGRAM EXEMPT/APA. Intro. 3/7/01. House committee substitute makes the following changes to 2nd edition: (1) changes title to read *AN ACT TO EXEMPT FROM THE NORTH CAROLINA FEDERAL TAX REFORM ALLOCATION COMMITTEE AND THE NORTH CAROLINA HOUSING FINANCE AGENCY FROM THE RULE-MAKING REQUIREMENTS OF THE ADMINISTRATIVE PROCEDURE ACT WITH REGARD TO ADOPTION OF THE QUALIFIED ALLOCATION PLAN;* and (2) and deletes those provisions authorizing the Joint Legislative Administrative Procedure Oversight Committee to study the applicability of the Administrative Procedure Act to the two agencies referred to in the bill's title.

Adds new amendment to GS 143-433.9 to exempt North Carolina Federal Tax Reform Allocation Committee from requirements of Art 2A of GS Ch. 150B when it adopts annual qualified allocation plan as required by 26 USC 42.
