S 42. CONTINUING BUDGET AUTHORITY. Intro. 2/5/01. Senate committee substitute makes the following changes to 1st edition. Replaces blank bill and changes title to *AN ACT TO AUTHORIZE THE DIRECTOR OF THE BUDGET TO CONTINUE EXPENDITURES FOR THE OPERATION OF GOVERNMENT AT THE LEVEL IN EFFECT ON JUNE 30, 2001, AND TO EXTEND EXPIRING PROVISIONS OF LAW*. Provides for continuation of expenditures until July 16, 2001. Provides that vacant positions subject to proposed budget reductions in either SB 1005, 3rd edition, or SB 1005, as it passes the House of Representatives, shall not be filled. State employees in positions subject to proposed budget reductions and state employees in positions funded with nonrecurring funds for fiscal 2000-01 shall be given notice of termination as required by law. Amends GS 143-26 to provide that except as otherwise provided by law, an annual appropriation of \$100,000 or less to or for the use of a nonprofit corporation shall be paid in a single annual payment, and payment of more than \$100,000 shall be made in quarterly or monthly installments, in discretion of Director of the Budget. If provisions of SB 1005, 3rd edition, SB 1005, as it passes the House of Representatives, or both, direct that funds shall not revert, the funds shall not revert on June 30, 2001. Unless funds are encumbered on or before June 30, 2001, funds shall not be expended after June 30, 2001, except as provided by statute effective after June 30, 2001. Effective June 30, 2001, and expires July 30, 2001.
