S 614. LOCAL ROADWAY EXPENDITURES. Intro. 3/22/01. Senate amendment makes the following changes to 1st edition. Changes title to *AN ACT TO AUTHORIZE THE TOWN OF CARY AND THE CITIES OF CHARLOTTE AND CONCORD TO EXPEND FUNDS ON ROADS OUTSIDE THE CORPORATE LIMITS AND FOR PARTICIPATION IN CONSTRUCTION OF ROADS OUTSIDE THE CORPORATE LIMITS BY THE DEPARTMENT OF TRANSPORTATION.* Makes act applicable to Charlotte and Concord. Authorizes Charlotte, Concord, and Cary to construct roadways (was, complete expanded roadway networks) as title indicates *if those roadways are owned by the State and maintained by the Dep't of Transportation.*

House amendment makes the following changes to 2nd edition: (1) changes title to *AN ACT TO AUTHORIZE THE TOWNS OF CARY AND WEDDINGTON AND THE CITIES OF CHARLOTTE, CONCORD, AND MONROE TO EXPEND FUNDS ON ROADS OUTSIDE THE CORPORATE LIMITS AND FOR PARTICIPATION IN CONSTRUCTION OUTSIDE THE CORPORATE LIMITS BY THE DEPARTMENT OF TRANSPORTATION,* and (2) adds Weddington and Monroe to those municipalities so authorized.
