S 627. LIABILITY INSURANCE FOR UNIV. STUDENTS. TO REQUIRE LIABILITY INSURANCE ON MOTOR VEHICLES OPERATED IN THE STATE BY STUDENTS ADMITTED TO CONSTITUENT INSTITUTIONS OF THE UNIVERSITY OF NORTH CAROLINA. Adds new GS 116-44.5A to require that every applicant for admission to a UNC constituent institution who operates a motor vehicle in NC must demonstrate proof of financial responsibility (as that term is used in the motor vehicles statutes, generally indicating coverage by liability insurance), and prohibiting admission of any such person who fails to make the proof. Amends GS 116-44.4(c) to direct institutions to enforce the requirement. These provisions would apply with respect to vehicles registered outside of North Carolina as well as those registered here. Effective Oct. 1, 2001, and applies to applications for admission and for registration of vehicles on or after that date.

S 627. LIABILITY INSURANCE FOR UNIV. STUDENTS. Intro. 3/22/01. Senate committee substitute makes the following changes to 1st edition. Deletes provisions of previous bill and replaces them with provision requiring students of the constituent institutions of the University of NC to provide proof of motor vehicle liability insurance before receiving a university parking permit.

S 627. LIABILITY INSURANCE FOR UNIV. STUDENTS. Intro. 3/21/01. House committee substitute makes the following changes to 2nd edition: (1) requires that no permit to park may be issued until the student requesting the permit provides the name of the insurer, the policy number under which the student has financial responsibility, and the student certifies that the motor vehicle is insured at levels set forth in GS 20-279.1(11) or higher (2nd ed., student need demonstrate proof of financial responsibility), and (2) changes effective date of act to Jan. 1, 2002, (2nd ed., Oct. 1, 2001) and applies to all student requests for permits to park submitted on or after that date.

Summarized in *Daily Bulletin* 3/22/01, 4/25/01, and 7/11/01. Enacted Aug. 3, 2001. Effective Jan. 1, 2002, and applies to all student requests for permits to park submitted on or after that date.
