Amends GS 17C-3 to change membership of Criminal Justice Education and Training Standards Comm'n to include the Sec'y of Dep't of Juvenile Justice and Delinquency Prevention and two correctional officers. Amends GS 17C-11 to clarify that enforcement powers of the Criminal Justice Education and Training Standards Comm'n include orders forbidding criminal justice officers from exercising their powers as well as power to receive appeals from denials, suspensions and revocation of certification. The third edition added five correctional officers to the NC Criminal Justice Education and Training Standards Comm'n. The committee substitute adds six General Assembly appointees to the Comm'n, three on recommendation of the Speaker and three on recommendation of the President Pro Tem., resulting in eight total General Assembly appointees. It also provides that at least one person recommended by each presiding officer must be a correctional officer in a management position.

Requires Joint Legislative Corrections and Crime Control Oversight Committee to study composition of NC Criminal Justice*

Education and Standards Comm'n to determine whether current number of members is sufficient or whether a smaller comm'n would be more effective, as well as appropriate representation. Committee to report findings and recommended legislative changes to 2002 Regular Session of 2001 General Assembly.
