**S 729. MOTORCYCLE INSURANCE RATES.** *TO PROVIDE THAT MOTORCYCLE INSURANCE RATES ARE SET IN ACCORDANCE WITH THE LAW REGULATING INSURANCE RATES RATHER THAN ESTABLISHED BY THE NORTH CAROLINA RATE BUREAU.* Amends GS 58-26-1(3) and GS 58-40-15 as title indicates. Repeals GS 58-36-65(m). Effective Oct. 1, 2001.

**S 729. MOTORCYCLE INSURANCE RATES.** Intro. 3/29/01. House committee substitute makes the following changes to 1st edition. Adds new GS 58-36-3 and rewrites GS 58-37-35(l), to provide that in the Articles dealing with the NC Rate Bureau and the NC Motor Vehicle Reinsurance Facility, the term "nonfleet private passenger motor vehicle" does not mean a motorcycle as defined in GS 20-4.01(27)d. Rewrites GS 58-37-1(6) (in relation to reinsurance facility) to provide that the term "motor vehicle" also means a motorcycle as defined in GS 20-4.01(27)d. Changes effective date from Oct. 2, 2001, to Jan. 1, 2002.
