S 888. NONRESIDENT LICENSE FEES. TO INCREASE THE FEES FOR NONRESIDENT HUNTING LICENSES, TO PROVIDE FOR A BEAR/WILD BOAR HUNTING LICENSE, AND TO MAKE OTHER CHANGES AFFECTING LICENSES ISSUED BY THE WILDLIFE RESOURCES COMMISSION. Amends GS 113-270.1C to provide that if a person who applies for a lifetime combination hunting and fishing license for disabled residents applies only for fishing privileges, the hunter education requirements do not apply to that person. Amends GS 113-270.2(c) and 113-270.3(b) to increase nonresident state hunting license fees and nonresident big game hunting license fees as follows: season license raised from \$40 to \$60, and six-day license raised from \$25 to \$40. Amends GS 113-270.3(b) to create nonresident bear/wild boar hunting license, in place of bear license; to increase fee for license from \$100 to \$125, and to exempt from need for license persons who have nonresident lifetime sportsman combination license purchased before May 24, 1994. Amends GS 113-270.4 to create nonresident hunting and fishing guide license, with \$200 fee, and to remove requirement that nonresident guide must be from state that allows NC residents to be guides. Amends GS 113-270.5(a) (trapping licenses) and 113-272.2 (special device licenses) to delete language about such license being annual. Amends GS 113-272.2 to raise fee for nonresident commercial special device license from \$100 to \$200. Effective July 1, 2001.

S 888. NONRESIDENT LICENSE FEES. Intro. 4/4/01. Senate committee substitute makes the following changes to 1st edition. (1) The bill amends GS 113-270.1C(b)(4), which provides for a lifetime combined hunting and fishing license for disabled residents, to provide that the application form for such a license must include the option of applying only for fishing privileges. The bill provided that in that case the individual was not subject to hunter education requirements; the committee substitute removes that provision. (2) The bill amends GS 113-270.4, which governs the licensing of hunting and fishing guides. The bill included a provision adding to the statute a requirement that the Wildlife Resources Commission's rules must include requirements for liability insurance coverage of guides; the committee substitute removes that provision.
