S 895. GEOGRAPHIC INFORMATION COORDINATING COUNCIL. TO ESTABLISH THE NORTH CAROLINA GEOGRAPHIC INFORMATION COORDINATING COUNCIL. Enacts new GS 143-275 establishing NC Geographic Information Coordinating Council (Council), charged with developing policies regarding utilitization of geographic information, GIS systems, and related technologies. Provides that Council to have up to 35 members, or their designees; Governor is to appoint nine or more members, representing state and local government and the public; Speaker and President Pro Tempore are each to appoint three members; and the heads of 10 listed state departments, the University and the Community College System, and the Utilities Comm'n are members as well as the State Budget Officer and others. Sets out terms of Council members and requires the Council to establish standing committees for state government, local government, federal agencies, statewide mapping, GIS, and management and operations. Directs that the Center for Geographic Information and Analysis is to staff Council and its standing committees. **Intro. by Reeves.**

Second edition provides that the members of the Council are to include one county employee and one member nominated by NC Ass'n of County Comm'rs (Association), and one city employee and one member nominated by NC League of Municipalities (League). Amendment deletes those provisions and provides instead that Council to include one county employee nominated by Association and executive director of Association, and one city employee nominated by League and executive director of League.

S 895. GEOGRAPHIC INFORMATION COORDINATING COUNCIL. Intro. 04/05/01. House committee substitute makes technical changes to 3rd edition and clarifies the membership of one of the Council's standing committees as follows: the Management and Operations Committee must consist of the Chair of the Council, the State Budget Officer, the chair of each of the standing committees, and other members of the Council appointed by the Chair. Provides that the act does not obligate the General Assembly to appropriate any funds and that the act shall be implemented from funds otherwise appropriated or available to the Governor.
