S 900. REVISE CJIN BOARD. *TO AUTHORIZE THE CRIMINAL JUSTICE INFORMATION NETWORK BOARD TO HIRE AN EXECUTIVE DIRECTOR; TO ESTABLISH THE BUDGET SUBCOMMITTEE OF THE BOARD; AND TO ESTABLISH THE CRIMINAL JUSTICE TECHNOLOGY FUND.* Amends GS 143-663 and 143-664 and adds new 143-665 as title indicates. Executive Director is to serve as chief information officer and is in particular to insure that the standards and information technology developed by the board adhere to the standards, procedures, and policies of the Office of Information Technology Services and the Information Resources Management Commission. New GS 143-663(a)(3)c. provides that the board is empowered to allocate funds (including state appropriations) to state agencies and departments that are part of the Network, including the dep'ts of Correction, Crime Control and Public Safety, Juvenile Justice and Delinquency Prevention, and Justice. New budget subcommittee is to be composed of the members who are the director or employee of state correction agency, employee of the Dep't of Crime Control and Public Safety, employee of the Attorney General, director or employee of the Administrative Office of the Courts, and chair or member of the Information Resource Management Commission, along with the Sec'y of Correction (or designee), Sec'y of Crime Control and Public Safety (or designee), director of the Administrative Office of the Courts (or designee), director of the State Bureau of Investigation (or designee), and the Attorney General (or designee). Budget subcommittee is to review the information technology needs of each agency and department that is part of the network, determine how these needs affect the network as a whole, and make recommendations regarding allocations from the Criminal Justice Technology Fund, created by this bill in new GS 143-666.

S 900. REVISE CJIN BUDGET PROCESS. Intro. 4/5/01. Senate committee substitute makes the following changes to 1st edition. Revises title to read, *TO MAKE CHANGES TO THE MEMBERSHIP OF THE CRIMINAL JUSTICE INFORMATION NETWORK GOVERNING BOARD; TO AUTHORIZE THE BOARD TO HIRE AN EXECUTIVE DIRECTOR; TO ESTABLISH THE BUDGET SUBCOMMITTEE OF THE BOARD; AND TO ESTABLISH THE CRIMINAL JUSTICE TECHNOLOGY FUND.* Adds amendments to GS 143-661(b) increasing the membership of the Board to twenty members (adds gubernatorial appointment of a member who is an employee of the NC Dep't of Juvenile Justice and Delinquency Prevention; deletes two legislative appointments who are from the general public; adds executive directors of the NC League of Municipalities and NC Association of County Commissioners or their designees). Revises GS 143-665 to add member who is employee of Dep't of Juvenile Justice and Delinquency Prevention to Board's subcommittee on budget and funding issues and adds Sec'y of same department as ex officio member of subcommittee. Specifies in GS 143-666 that Criminal Justice Technology Fund is nonreverting. Creates GS 143-667 to specify that act does not affect authority of members of network from seeking funds to meet these needs from sources other than this Fund.
