Changes title to read *AN ACT TO AUTHORIZE DARE COUNTY TO LEVY AN ADDITIONAL ONE-HALF PERCENT SALES AND USE TAX, A PRIVILEGE TAX ON PROVIDERS OF TRANSIENT ACCOMMODATIONS, AN ADDITIONAL ONE PERCENT PREPARED FOOD AND BEVERAGES TAX, AND A ROOM TAX, THE PROCEEDS OF ALL OF WHICH SHALL BE USED FOR BEACH RENOURISHMENT*. H 142. DARE LOCAL OPTION TAX MENU. Intro. 2/27/03. Senate amendment adopted 7/9/04 makes the following changes to 2nd edition. Makes technical changes only.

H 142. DARE SALES TAX (NEW). Intro. 2/27/03. Conference report recommends the following changes to 3rd edition to reconcile matters in controversy. Deletes provisions of bill related to privilege tax on innkeepers, meals tax, and room tax. Revises provisions of bill related to local option sales and use tax to increase amount of tax that may be levied from additional one-half percent to additional one percent. Adds provision that local option sales and use tax expires eight years after effective date of its levy. Adds provision that tax levied under this authority does not apply to construction material purchased to fulfill a lump-sum or unit-price contract entered into or awarded before the effective date of the levy. Amends title of bill to reflect deletions.
