H 173. COSMETIC ART/CONTINUING ED/PENALTY CHANGE (NEW). Intro. 3/3/03. House committee substitute makes the following changes to 1st edition. Replaces blank bill and changes title to *AN ACT REQUIRING THE CONTINUING EDUCATION OF PERSONS PRACTICING UNDER THE COSMETIC ART ACT AND CLARIFYING THE REMITTANCE OF CIVIL PENALTIES UNDER THE ACT*. Amends GS 88B-21 and 88B-29 as title indicates. Amendment to GS 88B-21 is effective October 1, 2003. Amendment to 88B-29 is effective when it becomes law and applies to violations occurring on or after that date.

H 173. COSMETIC ART/CONTINUING ED/PENALTY CHANGE. Intro. 3/3/03. House amendments make the following changes to 2nd edition. Add to GS 88B-21 provisions that (1) continuing education classes will be offered in secondary languages as needed and (2) promotion of products and systems shall be allowed at continuing education given in-house or at trade shows. Delete from the same section the requirement that a person who fails to renew his or her license within five years following its expiration date must pay the license fee for each year that the fees are delinquent in order to have the license reinstated.

H 173. COSMETIC ART/CONTINUING ED/PENALTY CHANGE. Intro. 3/3/03. House committee substitute adopted July 1, 2004 makes the following changes to 3rd edition. Amends GS 88B-21(e) by deleting exemption for certain licensees 55 years of age or older from continuing education requirements and adding prohibition on members of the NC Board of Cosmetic Art Examiners offering continuing education classes that are required by this section. Changes effective date of amendments to GS 88B-21 to October 1, 2004 (was, October 1, 2003).

H 173. COSMETIC ART/CONTINUING ED/PENALTY CHANGE. Intro. 3/3/03. Senate amendment makes the following change to 4th edition. Makes technical change only.

H 173. COSMETIC ART/CONTINUING ED/PENALTY CHANGE. Intro. 3/3/03. Senate amendment adopted 7/13/04 makes the following changes to 5th edition. Amends GS 88B-21(e) to exempt cosmetologists, estheticians, and manicurists who have practiced for a least 10 consecutive years and who are at least 60 years old from the continuing education requirements of the subsection.

COSMETIC ART/CONTINUING EDUCATION/PENALTY CHANGE. *AN ACT REQUIRING THE CONTINUING EDUCATION OF PERSONS PRACTICING UNDER THE COSMETIC ART ACT AND CLARIFYING THE REMITTANCE OF CIVIL PENALTIES UNDER THE ACT*.
