DISAPPROVE SWIFT CREEK RECLASSIFICATION. *TO DISAPPROVE THE ADMINISTRATIVE RULE RECLASSIFICATION BY THE ENVIRONMENTAL MANAGEMENT COMMISSION OF PORTIONS OF SWIFT CREEK AND SANDY CREEK IN THE TAR-PAMLICO RIVER BASIN THAT WOULD HAVE THE EFFECT OF IMPOSING CERTAIN MANAGEMENT STRATEGIES APPLICABLE TO OUTSTANDING RESOURCE WATERS (ORW) IN THE WATERSHED OF THESE CREEKS.* As title indicates disapproves rules adopted by the EMC on July 11, 2002, and approved by the Rules Review Comm'n on Aug. 15, 2002.

H 566. DISAPPROVE SWIFT CREEK RECLASSIFICATION. Intro. 3/20/03. House amendment makes the following changes to 1st edition. Makes technical change only.

H 566. SWIFT CREEK RECLASSIFICATION. Intro. 3/20/03. Senate committee substitute makes the following changes to 2nd edition. Approves Environmental Management Comm'n regulations covered by act for waters and lands located west of Nash County State Road 1003 (Red Oak Road) and disapproves regulations east of cited road. Directs Comm'n to adopt temporary and permanent rules to incorporate the provisions regarding approval and disapproval of the covered regulations.

H 566. SWIFT CREEK RECLASSIFICATION. Intro. 3/20/03. Senate amendment makes the following changes to 3rd edition. Recharacterizes the disapproval of the reclassification of Swift Creek and Sandy Creek east of Nash County State Road 1003 to Outstanding Resource Waters by requiring the reclassification to become effective only upon action by the 2004 Regular Session of the legislature. Authorizes the Environmental Review Comm'n to consider the matter and report findings to the 2004 Regular Session.
