H 735. CITY OF DURHAM/NOTICE TO CHRONIC VIOLATORS. *AUTHORIZING THE CITY OF DURHAM TO GIVE ANNUAL NOTICE TO CHRONIC VIOLATORS OF THE CITY'S REFUSE AND DEBRIS ORDINANCE WITHOUT FURTHER NOTICE THAT CALENDAR YEAR AND AUTHORIZING THE CITY OF DURHAM TO GIVE ANNUAL NOTICE TO CHRONIC VIOLATORS OF THE CITY'S OVERGROWN VEGETATION ORDINANCE WITHOUT FURTHER NOTICE THAT CALENDAR YEAR.* Authorizes the City of Durham to notify chronic violators of the city's refuse and debris ordinance that if the violator's property is found to be in violation, then the city may remedy the violation and charge its expenses as a lien on the property, without further notice. Defines "chronic violator" to mean a person who owns property against which, in the previous calendar year, the city took remedial action at least three times under the refuse and debris ordinance.
