H 963. HIT AND RUN-5 YEAR LICENSE REVOCATION. *TO PROVIDE THAT A PERSON CONVICTED OF LEAVING THE SCENE OF AN ACCIDENT INVOLVING INJURY OR DEATH SHALL LOSE THEIR LICENSE FOR A PERIOD OF FIVE YEARS.* Amends GS 20-166 as title indicates. Revocations apply to persons convicted of violation of GS 20-166(a) or (c). Authorizes limited driving privilege issued by judge pursuant to procedures and conditions in GS 20-16.1. Effective for offenses committed on or after Dec. 1, 2003.

H 963. HIT AND RUN - 2 YEAR LICENSE REVOCATION (NEW). Intro. 4/9/03. House committee substitute makes the following changes to 1st edition. Amends proposed new subsec. of GS 20-166(e) by limiting revocation of a drivers license for leaving the scene of an accident involving injury or death to a period of two years (rather than five years as provided in the 1st edition) and to violations of GS 20-166(a) (rather than to violations of GS 20-166(a) and (c), as in the 1st edition).

H 963. HIT AND RUN - 2 YEAR LICENSE REVOCATION. Intro. 4/9/03. Senate committee substitute makes the following changes to 2nd edition. Makes the two-year revocation permitted but not required.

June 10, 2003

H 963. HIT AND RUN - 2 YEAR LICENSE REVOCATION. Intro. 4/9/03. Senate amendment makes the following changes to 3rd edition. Makes license revocation mandatory for one year and within judge's discretion for second year, for violation of GS 20-166(a). (Formerly revocation for any period up to two years was within judge's discretion.)

H 963. HIT AND RUN - 2 YEAR LICENSE REVOCATION. Intro. 4/9/03. Conference report dated 7/14/03 recommends the following changes to 4th edition to reconcile matters in controversy. Provides that Division of Motor Vehicles (was, court) may revoke driver's license for an additional year if the court makes a finding that a longer revocation is appropriate under the circumstances. Makes technical changes.

SL 2003-394 (H 963). HIT AND RUN—2 YEAR LICENSE REVOCATION. *AN ACT TO PROVIDE THAT CERTAIN PERSONS CONVICTED OF LEAVING THE SCENE OF AN ACCIDENT INVOLVING PERSONAL INJURY OR DEATH MAY LOSE THEIR LICENSE FOR A PERIOD OF TWO YEARS.* Summarized in *Daily Bulletin* 4/9/03, 4/30/03, 6/3/03, 6/10/03, and 7/15/03. Enacted August 7, 2003. Effective December 1, 2003.
