**S 1058. UNC & COMM. COLL. TUITION/MILITARY STUDENTS.** *AN ACT TO PROVIDE THAT A MEMBER OF THE MILITARY OR A DEPENDENT RELATIVE OF A MEMBER OF THE MILITARY WHO ATTENDS A CONSTITUENT UNIVERSITY OR A COMMUNITY COLLEGE SHALL BE CHARGED ONLY THE IN-STATE TUITION RATE.* Amends GS 116-143.3 as title indicates. Effective July 1, 2004.

**S 1058. UNC & COMM. COLL. TUITION/MILITARY STUDENTS.** Intro. 05/13/04. Senate committee substitute makes the following changes to 1st edition. Changes proposed amendment of GS 116-143.3(b) to provide that active duty personnel reassigned outside of North Carolina shall continue to be eligible for in-state tuition rate and fees for as long as that person is continuously enrolled in the same academic program. Changes proposed amendment of GS 116-143.3(c) providing that dependents of active duty personnel reassigned outside of North Carolina shall continue to be eligible for in-state tuition rate and fees for as long as the dependent is continuously enrolled in the same academic program.

**S 1058. UNC & COMM. COLL. TUITION/MILITARY STUDENTS.** Intro. 5/13/04. House committee substitute makes the following changes to 2nd edition. Enacts new GS 116-143.1(h1), which provides that any reserve or active duty member of a NC National Guard unit who is a nonresident shall be eligible to be charged the in-state tuition rate. Enacts new GS 127A-202.1(f) (discrimination against National Guard members) making sec. applicable when a member of the National Guard is called into active duty. Changes effective date to Aug. 1, 2004 (was, July 1, 2004).

**SL 2004-130 (S 1058). UNC AND COMMUNITY COLLEGE TUITION/MILITARY STUDENTS.** *AN ACT TO PROVIDE THAT A MEMBER OF THE MILITARY OR A DEPENDENT RELATIVE OF A MEMBER OF THE MILITARY WHO ATTENDS A CONSTITUENT UNIVERSITY OR A COMMUNITY COLLEGE SHALL BE CHARGED ONLY THE IN-STATE TUITION RATE AND TO AUTHORIZE IN-STATE TUITION FOR NONRESIDENT MEMBERS OF THE NORTH CAROLINA NATIONAL GUARD AND TO CLARIFY LAWS PROHIBITING DISCRIMINATION AGAINST PERSONS WHO SERVE IN THE NORTH CAROLINA NATIONAL GUARD.* Summarized in *Daily Bulletin* 5/13/04, 7/7/04, and 7/17/04.
