S 137. SPECIAL OBLIGATION DEBT/PURPOSES. TO AUTHORIZE MUNICIPAL SERVICE DISTRICTS FOR TRANSIT-ORIENTED DEVELOPMENT AND TO AUTHORIZE CITIES TO USE SPECIAL OBLIGATION FINANCING FOR PROJECTS WITHIN MUNICIPAL SERVICE DISTRICTS. Amends GS 160A-536 as title indicates. Defines transit-oriented development projects to include public transportation services or facilities within a one-fourth mile radius of a passenger stop or station on a rail line, busway or guideway, including passenger stops and stations, parking facilities, downtown revitalization projects and other services or facilities in which the city is authorized to participate. Moves last sentence of GS 159I-30(a) to a new section 159I-30(g)(3) defining "projects" and adds services or facilities authorized by GS 160A-536 to definition of "projects." Makes technical corrections.

Replace bill with new bill that is similar to H 281, 6th ed., summarized in the Daily Bulletin of 7/16/03, with the following changes. (1) Delete amendments to GS 18B-101(7a), 18B-1104(7), 20-119, 48-2-206, 48-2-207, 48-2-304(c), 48-2-305, 48-2-401(b), 48-2-401(c), 48-2-405, 66-291(b)(2), 108A-70.21(d), 115C-238.29B(a), 238.29E, 115C-437, 120-2.2A, 126-3(b), 130A-2, 130A-2.1 – 2.3, Sec. 49.6.(d) (development of public health priorities by counties), 130A-2.4, 49.6.(i) (State Plan for Public Health Services), 130A-5, 131E-155, 131E-159, 131E-162, 143-508, 143-509(9), 143-518(a), 131E-256, 143B-437.51, Sec. 12.11 (Western NC Development Association, Inc.), Sec. 23.1 of SL 2003-284, Sec. 22.6 of SL 2002-126 (collection assistance fee account), Sec. 106 (Fayetteville State University proceeds from sale of chancellor's residence), Sec. 110.(a) (construction of cancer center), Sec. 111.(a) (exempting certain construction projects from GS 143-341(3) and 143-135.1), and Sec. 113.(a) (At-Risk and Improving Student Accountability allotments nonreverting). (2) Amend GS 20-7(b1) to clarify that person who applies for an identification card need not demonstrate an ability to drive a motor vehicle. (3) Change effective date of amendments to GS 95-138 to Oct. 1, 2003 (was, Jan. 1, 2004). (4) Amend GS 135-40.8(e) by deleting provision making subsection applicable if a Plan member has a medical emergency, is not capable of making a decision about choosing an in-state provider, and emergency services personnel transport the Plan member to a provider outside of Plan network. (5) Add effective date of Jan. 1, 2004, for new GS 163-166.12(b1). (6) Add effective date of Dec. 1, 2003, for new GS 20-141(o). (7) Amend Sec. 10.5 of SL 2003-284 by deleting Sec. 10.5(a), providing that DHHS may apply for a Medicaid waiver to provide for medication management for elderly persons (was, assistance in accessing primary care for elderly persons), and requiring that waiver include prescription drug benefit of not more than \$1,000 per person per benefit year and include copayment of at least \$5 per prescription for generic drugs and at least \$15 per prescription for brand name drugs (was, may provide prescription drug benefit). Further require that Dep't limit enrollment in Program based on fund availability. Require that no General Fund funds be used to support waiver. Require that Dep't report to Jt. Legis. Oversight Comm. on Governmental Operations on Program within 30 days of receipt of waiver. (8) Add new Sec. 102.1, requiring that all state entities that enter into construction contracts develop and implement a program to further increase opportunities for small, minority, and historically underutilized construction and construction-related firms to participate in such contracts. (9) Amend Sec. 30.16.(f) (authorizing contributions to TRICARE Supplemental Health Insurance programs to establish Dec. 31, 2004, expiration date. (10) Replace former Sec. 49.6.(f) with new Sec. 118.5, specifying several issues that planning comm. shall address. Makes technical and conforming changes.

The House recedes from amendments 1-4 (these amendments deleted the bill's original contents and converted it to a technical corrections bill, which failed to pass during the 2003 session). The effect of the conference report is to reinstate the second edition of the bill, engrossed 6/16/03.
